Fircrest Community Garden

Council is in the process of looking at the possibility of providing an area for a community garden on City property in Fircrest. A study session was conducted to review the guidelines and some possible locations. This effort is being presented by WeDig Fircrest, a group that desires to have a garden where residents can grow their own vegetables.

The areas being considered are in Fircrest Park on Spring Street near the City Park maintenance garage, on Electron Way next to the tennis courts and in Whittier Park near the restrooms and south of the tennis courts. The Well 6 & 7 site on Claremont Street near Sunrise Lane was discussed but was eliminated as not feasible.

Two local churches are also being looked at as alternative locations.

As you read this you are probably aware of our improvement project on Emerson to add sidewalks between Orchard St. and Alameda Ave. This project will hopefully be completed in late May or early June and also includes some improvements to the intersection of Water main improvements are planned along Ramsdell by a grant from the Transportation Improvement Board.

Another project is the upgrade of the Alameda Sewer Lift Station, located at approximately 46th and Alameda Ave. The 40 year old pump station will be upgraded with new pumps and better control systems. Scheduled to start in May and to be completed by October, this project is being These improvements help keep our City up to date and funded with the City's sewer capital improvement funds.

Traffic Signal improvements are planned for the signals at the intersections of Alameda and Regents and Alameda and Emerson. Design is underway this spring with

Construction season is here and will be for the rest of the construction to start in July. This project provides for crossings at these intersections and updates our signal equipment. We are anticipating only minor delays at these intersections during the construction time. This project is being funded by a grant from the Federal Highway Safety Improvement Program.

Alameda and Emerson. This project was partially funded from Contra Costa to Forest Park Drive. This project will be replacing an old water main that has had a couple of breaks over the last few years and needs to be replaced. This project is scheduled to be under construction in July. This project is being funded with the City's water capital improvement funds.
