Sign Code

The City Council adopted a new sign code that went into effect Wednesday, June 21, 2017. Thank you to staff, the Planning Commission and those business representatives who provided comments and participated in this year long process.



Sign regulations can be a win-win for both businesses and communities. They can improve the aesthetics of a community by encouraging original and artful identities while at the same time reducing visual clutter. Well-designed signage can create a positive impression that attracts people's attention and more effectively provides identification and direction.

Planning Commission Topics



Do you own an RV or boat? Does your neighbor? How about a broken down vehicle?

At the request of the City Council,

the Planning Commission has been looking at amending the regulations related to outdoor storage and parking of recreational vehicles, boats, trailers, and other vehicles, especially in front yards. Currently, the code allows two recreational vehicles to be place in the front yard and an unlimited number in the rear if screened. The current draft would limit recreational vehicles to one per residence and prioritizing storage to side and rear yards with appropriate screening. They are also looking to clarify the limits on parking of inoperable and commercial vehicles, while restricting the parking of any vehicle on lawns.

Home Businesses: Short-term rentals & Home Occupations

The Planning Commission is also reviewing regulations related to home businesses. They are looking to expand the



current regulations for bed and breakfasts to cover all short-term rental establishments. Short-term rentals are defined as rooms or houses that are rented for less than 30 days, for example Airbnb and VRBO. Proposed regulations would require permit approval, performance standards, and a current business license. Additional amendments are proposed for the home occupation standards to reflect the changes in technologies and employment trends.

The Planning Commission has scheduled a public hearing on **Tuesday, August 15th** to receive public input on these topics. Your comments - either written or in person - are encouraged and will help finalize the Planning Commission's recommendation to the City Council, who will hold an additional public hearing prior to making a final decision. The draft proposal is available on the website.

Yard Sales

Garage and/or yard sales are allowed with the following guidelines:

- The sale is for household items
- Purchasing items to resell at a garage sale is prohibited
- Sales are not to exceed four events or 12 days in any calendar year
- Signs cannot be attached to a utility pole, street sign, tree or fence nor placed on the street or sidewalk in a way that would interfere with traffic, pedestrians or property.
