We have a busy year ahead. A survey of City residents last year showed significant support for preserving the aging recreation center and pool. Both were built in the early 1960s and are in dire need of repairs and updates. The pool, especially, developed major leaks last year. City staff members are assessing options for repairing the leaks, but that will only buy us some time.

The Council and staff will be asking for your input as we assess options for the pool and recreation center. We are collecting as much information as possible about repairs, replacement, financing and design options. We expect to discuss it at every Council meeting for the foreseeable future. We will create a citizen advisory committee and share updates and requests for feedback in a variety of ways, including the City's website and Facebook page.

There are lots of other important initiatives under way, including plans to systematically replace our aging infrastructure, particularly water pipes that date to the mid-20th century. And we continue to update our zoning and development codes so the city is welcoming to small businesses.

PLANNING UPDATE

The City Council, Planning Commission, and staff conduct periodic review and evaluation of the City's Comprehensive Plan and Development Codes to ensure they maintain their effectiveness and respond to changing conditions. Below are some highlights of the past year and a preview of the coming year.

2017 in Review

- *Frequently Flooded Areas:* This update to the development code ensures compliance with the Federal Emergency Management Agency. Updated FEMA maps are available at City Hall.
- *Short-Term Rentals & Home Occupations:* Both of these sections were amended to recognize the changing in technology and home business trends. If you run an Airbnb or operate a home business, please give us a call to make sure you are in compliance.
- Annexation of the "chair": The previously unincorporated parcels in the 44th St West and 62nd Ave West area have been annexed to the City. We welcome our newest residents!

Preview 2018 - A few of the highlights included:

- *Commercial Zoning Districts:* The future vision, allowed uses and development standards will be reviewed for our two commercial districts as well as the building design standards. We anticipate public outreach to the parcels and businesses in this zone as well as the surrounding neighborhoods.
- *Code Compliance:* Staff will be taking a comprehensive look at the code enforcement regulations for planning, building, and nuisances to improve consistency, responsiveness, and success rates.
- Comprehensive Plan Update: As part of this annual review, staff will be amending the Comprehensive Plan to reflect the changes related to the recent annexation. Also, the Planning Commission will consider any private applications received. Please contact the Planning Department for more information.

PROJECT UPDATES

Emerson Sidewalk Project

This project is substantially complete. The contractor will be fixing a few remaining cleanup items. The street trees have a warranty period and will be monitored and probably replaced next spring. The sidewalks are open and ready for use. The City received a *Healthy Community Platinum Award* from the Tacoma Pierce County Health Department for this project.

Alameda Lift Station

This project is in the final stages of construction as the startup phase has begun. The final restoration will follow depending on weather conditions for the site work. This project is being funded with the City's sewer capital improvement funds.

Traffic Signal Safety Improvements

Traffic Signal improvements are planned to the signals at the intersections of Alameda & Regents and Alameda & Emerson. The project has been bid and awarded to Northeast Electric, LLC. The contractor is schedule to start up work in mid-February with construction taking about a month to complete. This project provides for improvements to the existing traffic signals and pedestrian crossings at these intersections and updates our signal equipment. Hopefully, minor delays at these intersection will be limited during the construction time. This project is being funded by a grant from the Federal Highway Safety Improvement Program.

Water Main Replacement on Ramsdell

Water main improvements are planned along Ramsdell from Contra Costa to Forrest Park Drive. This project is out to bid, with the bid opening scheduled for January 30, 2018. Construction should take place hopefully beginning in early March. This project is being funded with the City's water capital improvement funds.

Drake Street Lift Station

This project is updating this 50 year old pump station with new pumps and a better control system. The project is under design, which should be completed by the end of January. The project is scheduled to be bid early 2018 with construction during the summer of 2018. This project is being funded with the City's sewer capital improvement funds.
