- Bids may be withdrawn or modified by delivering a signed letter of withdrawal or modification to Colleen Corcoran, Finance Director prior to the bid deadline.
- In the event that it is necessary to amend, revise or supplement any part of the Invitation to Bid, the City of Fircrest will make a reasonable effort to provide the addenda to all bidders.
- The City of Fircrest may reject any or all bids, waive minor irregularities not affecting substantial rights and may for good cause, reject any or all bids upon a finding of the City of Fircrest is in the public interest to do so.
