Angelie,

Here are my comments regarding Case #18-06:

- 1. The proposed site plan doesn't show the (rock) retaining wall on the south side. Will the existing wall be impacted at all with this development? If so, how and are there any mitigation factors to consider? I haven't studied a survey lately, but if the applicant needs to install a new concrete retaining wall to gather a few feet of their property, I am supportive as long as they pay for all costs and install a chain-link fence on top of the wall. I am also supportive of removing the existing fir trees and replacing with new smaller trees that meet City of Fircrest landscape code. The existing trees will at some time be prone to blow over in a wind storm.
- 2. There are two underground water services, one for domestic and one for fire that run along the property line on the west side of the subject proposal. These waterlines service my property as well as Contac 38 LLC's two buildings. I know in the past the previous property owner's trees had to be removed because the roots were damaging these waterlines. About 10 years ago the roots caused a leak, and there was an emergency repair completed; the trees were removed. These waterlines service "Sunrise Center", property which a portion is owned by 2101 Mildred LLC, which I am Manager. The two water meters are in the Right-of-Way along 19th Street. There is also a storm sewer line. I am concerned that any future development of the subject site must recognize the delicacy of the property line area and these waterlines and storm sewer lines that have been in place for decades.
- 3. The plan shows an interesting ingress/egress from WB 19th Street.
- 4. I am excited to welcome Chick-fil-A! Please have them contact me for any assistance. <u>I support this</u> project.
