PUBLIC HEARINGS

Case No. 18-04 Amendments to Type II-A Public Notices (FMC 22.07.004 and .005)

Planning and Building Administrator Stahlnecker presented the staff report for the proposed amendments. Staff recommends increasing the public notice for Type II-A permits (staff reviewed applications) to 300 feet for commercial projects and extending the comment period for all to 14 days.

Case No. 18-05 Amendments to Accessory Structure Setbacks (FMC 22.58.003)

McVay opened the public hearing for Case No. 18-05 at 6:10 p.m.

Planning and Building Administrator Stahlnecker presented the staff report for the proposed amendments. Staff recommends establish the setback for accessory structures that do not require permits to five feet for rear yards of through-lots and side street side yards. Currently, they are the same as the principal structure. In additions, staff recommends increasing the setback for interior rear and side yard from three feet to five fee for accessory structures. The increase setback would provide better fire, run-off, and privacy protection.
