NEW BUSINESS

Chief Cheesman discussed the passing of I-940 and that the initiative will create a good faith test to determine when the use of deadly force by police is justifiable, require police to receive de-escalation and mental health training, and require law enforcement officers to provide first aid. He stated that all officers received 10 hours of Crisis Intervention training last year. Due to the lack of lateral applications received it was determined that we would re-post the job opening advertisement to include new verbiage that would encourage applicants to apply based on anticipated openings within the department. South Sound 911 will be assisting officers with warrant information to streamline the warrant process. The crime mapping program has geo-coding on all crimes which will allow all officers to see the statistics in a neighborhood. Officer Chris Roberts has been unable to work in 2019 due to an off duty injury. Chief Cheesman said he was expected to return the end of March. Sergeant Miller is doing great. He is scheduled for first level supervision training in April. Chief also reported that the two new police cars are in.


