Mayor's Message



If you're old enough, like me, then you have learned to automatically adopt certain habits, such as always wearing a seatbelt in the car, silencing your cell phone in the movie theater, and separating your garbage from your recycling.

But that recycling habit is becoming a lot less virtuous.

There has been a lot of news coverage about the precipitous drop in the recycled materials markets, but in case you missed it here's the gist: for years, the stuff you put in those big blue bins was sold and shipped overseas, mainly to China. But last year China stopped taking plastics, mixed paper and other materials from the United States. The market for our empty orange juice bottles, newspapers and cat food containers (well, there's a glimpse of what's in my can) suddenly dried up.

It doesn't take an economics degree to understand what happens when there's no market for certain goods. Recycling programs in cities across the country are bleeding red ink. Some cities are limiting what items they'll accept.

Our friends at the City of Tacoma are asking their customers for feedback on some drastic options that range from eliminating curbside recycling to maintaining full services and raising rates \$4 a month. At the moment, there are no changes to the recycling program in Fircrest. But that doesn't mean there isn't an impact.

While the City of Tacoma operates its own garbage and recycling service, the City of Fircrest has a multi-year contract for those services with University Place-based Westside Disposal.

Westside Disposal used to offset some of its operational costs by earning an average of \$26,421 a year in revenue from selling its recycled commodities. However, last year the company had to pay \$32,307 to the recycling plant.

Earlier this year, the company asked the Fircrest City Council for permission to add a 2.57% surcharge to monthly bills for one year in order to recoup those losses. That would have added 81 cents to the most popular service (64-gallon bin).

It doesn't sound like much, but Councilmembers wrestled with the principle of it because that's why we have a contract — to protect you against fluctuations in rates.

For now, the City Council decided to decline the company's request. Councilmembers also agreed to revisit the issue (possibly at our study session on April 15). This is a global problem that affects a company that has provided outstanding and efficient service to our residents for many years. A Message from Police Chief John Cheesman: Protect Your Car From Theft

As the weather gets warmer and the days get longer, more and more people are out moving around and enjoying this time of year. Unfortunately, our law abiding citizens are not the only ones out moving about more. The criminal element is as well. This time of year we see a rise in vehicle prowls in Fircrest. In 2018, we responded to 109 thefts in our city and many of them were from vehicles. In several recent cases the victim vehicles were left unlocked and valuables were not only left in the victim's vehicle but also were left in plain sight. Let's not make it easy for thieves. Following these simple guidelines will make it difficult and less inviting for would be thieves to come into our community.

- Never leave keys inside the vehicle
- Ensure that the windows are all the way up before locking your vehicle
- Lock your vehicle even if you are going to be away for a short time
- Be sure to activate your vehicle alarm whenever you exit/lock your vehicle
- · Remember to remove portable GPS devices
- Lock your vehicle even if it is parked in your driveway, inside your garage or on the street in front of your residence
- Do not leave valuables inside your vehicle even if it is locked (i.e. purses, wallets, cell phones, computers, cameras, shopping bags, backpacks, etc.)
- If you have a removable faceplate on your stereo, always remove it and take it with you.
- If you see anyone acting suspiciously in the area of your vehicle or in your neighborhood, please report it immediately by calling 911.
- Do not keep a "Hide-a-Key" in the wheel well. Vehicle prowlers will often look for this. When they find one not only will they be able to steal your property inside your vehicle, but you have now made it easy for them to steal your vehicle.

These simple steps will deter most would-be thieves. Do not hesitate to call 911 immediately if you see ANYTHING or ANYONE that seems out of place or suspicious. We cannot do our jobs effectively without the help and assistance of those we serve. Don't become a victim and as always, let's watch out for each other.

Public Works Capital Projects Update

High Tank Site Painting Project

This project is to coat the exterior of both tanks at the High Tank Site. This helps preserve the tanks and will also provide a new logo on the high tank. The project has been awarded to Long Painting Company The painting will take place mid to late summer to make sure the weather cooperates with us. This project is being funded out of the REET funds.

Water Main Replacement on 400 Block of Summit Avenue

Water mains that are undersized and old will be replaced along this block. This will be done by our public works crews and is schedule to be done in the summer months. This is funded by the water capital fund.

Farallone Avenue Storm drain improvements

A new storm line will be installed along the 1200 block of Farallone. This work is funded from the storm capital budget and will be done by our public works crew. This is scheduled to take place during the summer months.

Connection of Sanitary Sewer Main on 100 Block of Farallone

This project is connecting existing backyard sewer mains that were previously done and rerouting the sewer line to replace an existing line that runs underneath a house. The project is under design and construction is scheduled to take place early summer. The project is funded by the sewer capital fund.

Alameda Avenue Grind and Overlay Project

This project is resurfacing Alameda Ave. between Regents and Columbia. The City received a grant for this work from the Puget Sound Regional Council. The project is under design and should be constructed when school is out for the summer and completed before school starts again.
