# Mayor's Message



The voters of Fircrest spoke loud and clear on April 23 when they overwhelmingly approved the

park bond to pay for a new pool and community center as well as other park improvements.

In case you haven't seen them, here are the final numbers from the special election:

YES:	1,716	79.15%
NO :	452	20.85%

The final vote tally was 2,168, which was far ahead of the minimum 1,418 needed in order for the results to be validated. And a final piece of trivia: 681 ballots were submitted via the Pierce County ballot drop box at Fircrest City Hall.

As they say on TV, "but wait, there's more!" We have promised to continue seeking grants and donations to fund this project, and I'm excited to let you know about a big achievement. The threemember delegation that the represents us in Rep. Mari Legislature -Leavitt, Rep. Christine Kilduff, and Sen. Steve O'Ban of the 28th Legislative District helped us get a \$1 million grant from the state. That's the Legislature's second grant for this project, and it brings the state's total contribution to \$1.75 million. We are very grateful for the strong support from our legislators, and I hope you will take a moment to share your appreciation when you see them in the community.

On behalf of the City of Fircrest, I want to thank a number of people who contributed their time and talent to get us to this point.

First, I thank the residents who volunteered to serve on project steering the committee. This group of 15 people met throughout 2018 and into mid 2019 to do a deep dive into every aspect of the pool and community including building center, design, layout, landscaping, furnishings, and the business plan. They represented a cross-section of the community, including families, seniors, the Fircrest Soccer Club, the Kiwanis Club, and more.

Second, I thank our staff and City Council members. City Manager Scott Pingel and Parks and Recreation Director Jeff Grover served as the points of contact with ARC Architects and the steering committee. Councilmember Brett Wittner served as chairman of the steering committee, and

Councilmembers Blake Surina and Shannon Reynolds helped represent the Council during those in-depth discussions.

This project began five years ago when we updated the City of Fircrest's Parks, Recreation and Open Space Plan. Since then, a lot of people have put a lot of work into developing and designing a new pool and community center that will serve future generations. Thanks to overwhelming support from voters, we are putting that plan into action.

Building Project Tips-The What, Where, How and Who

**What can I build?** The City's development (zoning) code lists what is allowed in each neighborhood. Some things like houses are allowed outright; others, like "granny flats" or short-term rentals need special approval.



Where can I build? Different structures have

different rules on where they can be built on the property. Generally speaking, other than fences, structures have a specific setback – i.e. how close it can be to the property line. Speaking of property lines, knowing where they are is very important. And while a survey gives the exact location, we can provide a map with estimated property lines.

*How can I build?* There are specific construction rules, design standards, and structure regulations that regulate anything from fences to sheds to pergolas.

Who knows all this stuff?! Your local planning and building department! They will help you understand what you can build, where you can build it, and how you get there. A conversation early in the process gives peace of mind and saves unnecessary headaches.

#### **City Manager's Corner**



Hello Fircrest Residents,

For this edition of Town Topics, I want to share a couple of examples of great work on the part of your community and local government.

As we look to the future with the pool and community center project, we have worked hard to get the current pool ready for the 2019

pool season. Each year over the last few years, this task has become a little more difficult as the pool continues to deteriorate.

During last year's pool season, the pool sustained a major tear in the liner on the side of the stairs, as well as a tear at the bottom of the deep end. As the pool liner dried out in the off-season, it became brittle, and the tear turned into a rip all the way across the stairs. Options for repairing such a large rip were limited, especially since this will be the last summer for this pool. In looking for ways to repair the rip, Andy Piercy, our Parks Supervisor and Pool Operator, along with Jeff Grover, our Parks and Recreation Director, had the insight to contact a roofer rather than looking to traditional pool maintenance options. Acme Roofing, located in Fircrest, came out and sealed patches on the liner using a method for sealing roofs.

Hats off to Andy and Jeff for innovative problem solving, and hats off to Acme Roofing for coming through with applying a roofing method to a pool liner. While we were not able to

open the pool over Memorial Day weekend as we usually do, thanks to savvy staff and a great community partner, we were able to get the pool opened for the 2019 season.

Another example I would like to highlight concerns the City's Municipal Court and our Planning and Building Department. The City of Fircrest offers passport services, and this used to be provided out of the Municipal Court. At the beginning of 2019, the City of Fircrest began providing Municipal Court services for the City of Ruston. Providing court services for another city is a fairly major undertaking, so we decided to move passports services out of the Court.

As so many agencies are no longer providing passport services, the City of Fircrest wanted to keep providing the service. Moving this service to another department would require new staff to be trained and approved through the U.S. Department of State, and the additional time it takes to provide the service as patrons come through. Our two Planning and Building staff (Angelie Stahlnecker, Planning and Building Administrator, and Jayne Westman, Permit Tech) stepped up to take on passports through the Planning and Building Department, with Lindsay Davis, one of our Accountants, being trained to back them up. While the passport service can be busy at times, these staff have done a great job working it into their day-to-day work.
