### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the City of Fircrest from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Courts Monitoring procedures and agreement for Court Services
- Parks and Recreation/Pool Cash receipting for timeliness and completeness of deposits, voids, and adjustments.
- Bid law and Prevailing Wages compliance with requirements for public work projects.
- General Disbursement travel expenditures, employees and elected officials reimbursements, and other payments.

## INFORMATION ABOUT THE CITY

The City of Fircrest, incorporated in 1925, serves approximately 6,640 citizens. The City provides public safety services, a Municipal Court, street improvements, parks and recreation, planning and building services, and general administration. In addition, the City operates water, sewer and storm drainage utilities.

An elected, seven-member Council governs the City. Council Members select one of its members to serve as Mayor every two years. The Council appoints a Manager to oversee the City's daily operations and its approximately 30 full-time employees. For fiscal year 2018, the City operated on budgets of just over \$26 million.
