Definitions:

TRANSIENT MERCHANT: Is any person, firm or corporation who shall engage in, do or transact any temporary business at wholesale or retail for the sale of goods, wares or merchandise, or services and who for such purpose shall have, use or occupy any building, vehicle, booth or other structure, either temporary or permanent, for the exhibition and/or sales of such property or services.

PEDDLER: is any person who shall sell, attempt to sell, or solicit the sale or services, of goods, wares or merchandise, including sales by sample or for future delivery, or services, by going from place to place or from house to house, or in any other place not used by such person as a permanent place of business. This includes door to door solicitation.

STREET SELLER: is a person who shall sell, attempt to sell, or solicit the sale or purchase of goods, wares or merchandise, or services, from a location on any street, alley, sidewalk or other public thoroughfare, whether for present or future delivery or performance.

CANVASSER: Is a person who seeks contributions, donations, opinions, preferences or other information for commercial purposes.

SURETY BOND: Every applicant shall file with the City a bond in the amount of \$1,000 executed by the applicant as principal and a surety company authorized to do business in the state of Washington, running in favor of the city, conditioned that any person who may suffer any loss or damage by reason of any malfeasance, misfeasance, or deceptive practice in the conduct of such solicitation or canvass shall have the right to institute an action for recovery against the licensee and the surety upon such bond.
