CALL TO ORDER AND ROLL CALL

The Investment Committee met in the City Hall Council Chambers on July 23, 2018. Mayor Hunter T. George called the meeting to order at 3:00 P.M. Committee members Denny Waltier, David M. APPROVAL OF MINUTES

Corcoran MOVED to approve the minutes of the April 23, 2018 Investment Committee meeting; seconded by Waltier. The Motion Carried (4-0).

NEW BUSINESS

A. Review of Current Investments

Corcoran provided a summary of the City's current investments and recommended the Investment Committee not take any action to change investments or to invest additional funds. There was a brief discussion on investment maturity dates, historical interest rates, and bond markets.

B. Review of Available Funds for the Community Center and Pool Project

Pingel provided a brief summary of REET 1, REET 2, and 44th/Alameda funds. There was a brief discussion on potentially using councilmanic bonds for the community center and pool project. Pingel indicated staff had not prepared a recommendation for councilmanic bonds but could perform an analysis if it was desired. There was additional discussion on 44th/Alameda funds and how the community center and pool project bond, if approved, would help to recover funds expended for ARC Architects. After a brief discussion on utilizing REET funds and other City funding, Pingel indicated that the City could allocate \$200,000 from 44th/Alameda and \$500,000 from REET 2 to the community center and pool project.
