1 **CITY OF FIRCREST RESOLUTION NO. 1717** 2 A RESOLUTION OF THE CITY COUNCIL OF THE 3 CITY OF FIRCREST, WASHINGTON, ESTABLISHING THE COVID-19 RELATED BUSINESS, RENTAL AND 4 UTILITY ASSISTANCE PROGRAM. 5 WHEREAS, the Fircrest community continues to be impacted by the COVID-19 6 pandemic; and 7 WHEREAS, the American Rescue Plan Act (ARPA) provides direct aid to cities in order 8 to respond to the COVID-19 pandemic, cover costs incurred from the public health emergency, replace lost, delayed, or decreased revenues due to COVID-19, address the 9 negative economic impacts on local businesses and nonprofits, and make necessary investments in water, sewer and broadband infrastructure; and 10 WHEREAS, the City of Fircrest will receive \$1,907,976 in direct aid from the U.S. 11 Treasury Department through the Washington State Office of Financial Management and 12 the Coronavirus State and Local Fiscal Recovery Fund; and 13 WHEREAS, the Firerest City Council recognizes that one of its essential functions is to secure the health and welfare of Fircrest's citizens; and 14 WHEREAS, resources are necessary to help Fircrest residents that continue to be impacted 15 by job loss or reduction and the difficulties that result from this situation; and 16 WHEREAS, resources are necessary to help small businesses survive and certain small 17 businesses reasonably require public aid in order to survive; and 18 WHEREAS, the City completed the requirements to receive direct aid pursuant to the 19 American Rescue Plan Act through the Coronavirus State and Local Fiscal Recovery Fund administered to Non-entitlement Units through the Washington State Office of Financial 20 Management. Now, Therefore 21 BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FIRCREST: 22 **Section 1.** The Recitals and referenced Exhibits are incorporated herein by this reference. 23 **Section 2.** The City of Firerest, hereby, establishes the COVID-19 Related Business, 24 Rental, and Utility Assistance Program to provide grants through funds the City receives through the American Rescue Plan Act State and Local Fiscal Recovery Fund. Grant 25 awards will be at the sole discretion of the City of Fircrest through an application process. 26 Grant recipients shall only receive and use grant funds for Eligible Expenses incurred during the time period set forth in Section 3. A list of business assistance award eligibility 27 and criteria, as well as eligible and ineligible expenses, are included in Exhibit A. 28 29

| 4 | Section 4. All funds for this program come from the American Rescue Plan Act State and Local Fiscal Recovery Fund specifically provided to the City of Firerest. The City has no obligation to provide grant recipients or applicants with funds from this or any other source. |

| 7 | of the Non-entitlement Unit Award Terms and Conditions, included as Exhibit B to this Agreement. |
| 8 | Section 6. Grant applicants acknowledge that grant funds shall not be awarded to cover |
| 9 | payroll or other employee-related or business-associated costs for which they have received other federal, state, or regional funds, including without limitation, funds made available |
| 10 | under the Payroll Protection Program (PPP) or unemployment insurance compensation. |
| 11 | Section 7. Rental and utility assistance grants will be made available to Fircrest residents. Rental assistance grants will be paid directly to the recipients' landlord. Utility assistance grants will be paid to the City of Fircrest and credited to the applicants' utility account. |
