
Change In Operating Revenue: +\$832,940

- Property Tax/EMS Levy: + 1% and new construction value.

AN ORDINANCE OF THE CITY OF FIRCREST, WASHINGTON, AMENDING SECTION 1 OF ORDINANCE NO. 1660 AND F.M.C. 2.44.050 RELATING TO SALARIES AND BENEFITS OF NON-UNION CITY EMPLOYEES AND AMENDING SECTION 2 OF ORDINANCE NO. 1660 AND FMC 2.44.090 RELATING TO HOURLY RATE OF PAY FOR CASUAL AND SEASONAL EMPLOYEES.

THE CITY COUNCIL OF THE CITY OF FIRCREST DO ORDAIN AS FOLLOWS:

Section 1. Section 1 of Ordinance No. 1660 and F.M.C. Section 2.44.050 are hereby amended to read as follows:

"Non-Union Salaries. From and after January 1, 2022, the full-time equivalent monthly salary range of the following regular full-time, regular part-time, and temporary City positions is fixed at the following sums. No employee shall be paid an average monthly base salary, which exceeds the maximum provided hereunder.

HB 1223 Uniform
Electronic
Recordation of
Custodial
Interrogations
Act

Effective January 1, 2022

- Requires that **any** custodial interrogation of an adult for a felony offense OR a juvenile for **any** offense that takes place in a jail, detention or police ANY facility must be audio and video recorded to be admissible.
- Custodial interrogations that occur in a police vehicle or school must be audio recorded at a minimum.
- Officers must document <u>any</u> exceptions in a written report, and agency must have a policy and procedures in place to implement the act by its effective date.
- Limited exceptions: spontaneous statements, exigent circumstances, refusal by interviewee, interviews outside of WA, safety concern (confidential informants), equipment malfunction, or good faith belief that recording not required.

This bill is a "de-facto" body cam requirement.




- · Include Miranda warnings and waivers on recording
- · Requires notice of recording, but not consent to record
- Subject refusal is an exception, so capture that refusal or agreement on record if possible.
- Capture exigent circumstance if feasible before interrogation or as soon as possible after
- Must document in a written report any decision to interrogate an individual outside a "place of detention" (jail, holding cell, police facility, patrol vehicle, or school)
 - Keep in mind some adult misdemeanor offenses may be felony offense depending on prior convictions. Under the good faith belief exception, once facts lead you to believe, must record!!
