Section 1 of Ordinance No. 1628 and FMC 3.20.360 are hereby amended to 11 read as follows: 12 3.20.360 Petty Cash funds. 13 (a) There are created and established change funds as follows: 14 Custodian Amount Finance Director 15 \$125.00 Court Administrator \$200.00 16 Parks/Recreation Director \$ 90.00 17 (b) There are created and established revolving cash funds as follows: 18 Custodian Amount 19 Police Chief \$ 50.00 Finance Director \$410.00 20 Parks/Recreation Director \$125.00 21 (c) Each change fund and revolving cash fund will be maintained and monitored in accordance with methods prescribed by the State Auditor's Office. 22 23 **Section 2. Corrections.** The City Clerk and codifiers of the ordinance are authorized to make necessary corrections to this ordinance including, but not limited to, the correction 24 of scrivener/clerical errors, references, ordinance numbering, section/subsection numbers, and any references thereto. 25 26 Section 3. Severability. If any section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason, such invalidity shall 27 not affect the validity or effectiveness of the remaining portions of this ordinance. 28
