3. Administration

Administration highlights include:

- Over 75% of City employees met with the City's Aflac representative this past week to learn more about supplemental insurance offered through their employee benefits. All full- and parttime employees will now receive health advocacy and wellness, as well as financial/legal fitness Aflac services, at no cost.
- A Civil Service Lateral Police Officer oral board was held on February 5th, with one applicant interviewed. Another oral board will be scheduled in the coming weeks to interview additional candidates who have recently submitted application materials.
- City Manager Masko, Public Works Director Bemis, and Project Coordinator Bob Jean continued to meet to discuss the sewer interlocal agreement.

- The rescheduled February Civil Service Commission meeting will be held on Tuesday, February 13th, at 4:30 PM at City Hall. The Lateral Police Officer eligibility list will be certified at this meeting. The <u>eligibility list</u> is posted on the Civil Service Commission <u>webpage</u>.
- The City received three public records requests this week for a total of 27 requests in 2024.
- City Manager Masko continued to spend a significant amount of time on personnel issues.
- The first review of applications for the Recreation Specialist position was on February 6th. The City received a total of five applicants for the position.
- City Manager Masko continues to follow legislative session activities. The Association of Washington Cities (AWC) releases an <u>AWC Hot Sheet</u> every week, which is intended to serve as an easy reference guide for certain bills of interest to cities, as well as a <u>Bill Tracker</u> webpage, which covers legislative bills for a wide array of topics.
- Acting City Clerk Arlette Burkhart continues to review educational webinars regarding employee benefits and best practices and has also created a tracking log for Council proclamations passed since 2018.
- City Manager Masko, Public Works Director Bemis, and Project Coordinator Bob Jean continued to meet to discuss the sewer interlocal agreement.
- City Manager Masko worked with City departments on the Community Center close-out, public records requests, utility rate increases, and the 2024 Budget Document. She also began working on the development of a comprehensive taxes, rates, and fees schedule.
- In the last 30 days, the City's website has had 22,336 page views with a total of 6,135 users.

4. Police Department Update

Fircrest officers responded to 185 calls for service for the period of 1/28/2024 - 2/4/2024, including 107 traffic stops, which generated 68 notices of infraction. Additional information is provided in the chart below.

- Officers Roberts and Bugarin arrested a male with an outstanding felony warrant at a residence in the City.
- Sergeant Gollinger attended the Wainwright Intermediate School lockdown drill on February 7th.
- The Civil Service Oral Board interviewed one lateral candidate on February 5th. The Civil Service list will be certified by the Civil Service Board on February 13th. We have received two additional applicants and will schedule oral board interviews for them in the next few weeks.
- Chief Ron Schaub attended the Public Safety Communications Operations Committee meeting at South Sound 911 on February 9th.
- Chief Schaub's interview by former Councilmember Joe Barrentine for his Fircrest-specific podcast 7 Trees is now <u>online</u>.

5. Finance Department Update

Finance Director Colleen Corcoran and City Manager Masko are working to schedule interviews with the top candidate(s) for the part-time Accountant position next week.

6. Parks & Recreation

- Unfortunately, the City recently became aware of an attempted scam targeting one of our event vendors. Prospective vendors typically apply to participate in our City events via Jotform. Recreation staff review all applications and assign vendors to specific events based on their applications. Several weeks before each event, vendors are invoiced through RecDesk. In this particular case, a vendor received a social media direct message requesting payment through Venmo. Thankfully, the vendor alerted City staff before proceeding with payment. In response, we have drafted and distributed a statement to all of our vendors, urging them to exercise caution when receiving communications that deviate from our standard procedures. We emphasize the importance of using caution and encourage vendors to reach out to us for clarification if they encounter any suspicious activity.
- Pierce Conservation District recently hosted their monthly work party at Whittier Park, where they successfully planted a variety of native plants and ground cover.

Projects

- Whittier Park Master Plan Parks & Recreation Director Jeff Grover met with AHBL last Friday and got a sneak peek at two promising concepts for Whittier Park that they have developed. They will continue to deliberate and refine the information as they move towards selecting one final concept. Once Director Grover receives the draft concepts, he can initiate discussions on potential next steps and logistics for scheduling an additional meeting.
- Community Center Close-out Director Grover is moving forward with final project close-out.

Recreation Programs

- Councilmember Nikki Bufford served as our guest reader during Tot Story Time this week. She captivated a capacity crowd of toddlers and their adults on Tuesday morning by reading *Max and the Tag-Along Moon*.
- Recreation staff are currently working to develop a more comprehensive volunteer program for after-school activities, including chess, video games, and gym activities.

7. Planning & Building Update

- The City issued one mechanical permit this past week for the installation of a new heat pump.
- The City received six new code enforcement requests this week:
 - Two requests regarding an abandoned vehicle in the right-of-way (ROW) on the 1500 block of Cherry Avenue. Code Enforcement Officer Kristin Singh forwarded the requests to the Firerest Police Department Community Service Officer for review.

- o Potholes and uneven pavement at the intersection of Center Street and South Orchard Street in the City of Tacoma's ROW. The request was forwarded to Public Works for review.
- o An uncovered communications pedestal in the Claremont Street ROW at 64th Avenue. The request was forwarded to Public Works. The pedestal has since been fixed.
- Two requests regarding an eroding rockery wall obstructing the sidewalk on Claremont Street between Claremont Court and Panorama Drive. The requests were forwarded to Public Works, which is working with the adjacent property owner to have the wall fixed.
- Staff continues to monitor code enforcement issues at the 500 block of Golden Gate Avenue to create a plan to address the situation.
- An architectural firm is under contract to design a proposal for the Orchard Street Properties (commonly referred to as the Bourgaize Property). The firm has indicated an interest in submitting a docket request for an amendment to the upcoming 2024 Comprehensive Plan for a map change (land use) amendment. This type of map amendment adjusts the Comprehensive Plan land use map to allow a different use and prepares an area for future rezoning. Once the applicant formally submits an application and shares plans, Community Development (CD) Director Mark Newman will pass this information on to the City Council, the Planning Commission, and the public, as well as open up the annual docket request application.
- CD Director Newman helped facilitate a discussion on the 2024 Comprehensive Plan during the February 6th Joint City Council/Planning Commission meeting. Discussion focused on the review process, budget, and public outreach strategy for review of the draft.
- CD Director Newman will be attending the Four Corners/Thriving Communities meeting focusing on the South 19th Street and Mildred Street West area on February 21st.
- The Department of Commerce has alerted the City that the grant amount of \$22,500 awarded to install four Electric Vehicle (EV) Charging stations as part of the WAEVCP grant was incorrectly calculated. A revised grant award amount will be released by Commerce next week.

8. Public Works Update

Public Works is operating under winter hours from 8:00 AM to 4:30 PM.

Highlights include: (in addition to routine daily tasks)

Utilities - Water, Sewer, Streets, and Stormwater

- Two utility staff members and one facilities staff member attended the Evergreen Rural Water Conference this week as part of maintaining their required Continuing Education Units (CEUs).
- Permanent asphalt repairs at various locations, including South Orchard Street, were performed on February 6th and 7th.
- The old bucket truck passed the required dielectric boom test and is now ready for sale. Plans are to post this piece of equipment for sale locally before sending it to auction.

Maintenance – Parks & Facilities

• The new security system installation is now completed at City Hall, and the fire monitoring equipment installation is in process.

Project Updates

- Well #7 (Claremont)
 - We are seeking multiple bids utilizing the MRSC Small Works Roster.
- Fircrest Park Maintenance Facility Structure Upgrade
 - o We are seeking multiple bids utilizing the MRSC Small Works Roster.
- 44th Street West & 67th Ave West Lift Station Upgrade
 - Notice to Proceed has been provided, and we are identifying dates for preconstruction meetings and preordering of materials.
- Storm Water Pre-Treatment Outfall Grant Project Emerson Street & Estate Place
 - o Final close-out Progress Reports and Payment Requests are in progress.
- AMI Water Meter Exchange Program
 - o Program completion is at 49%. Exchanges have been on hold due to reduced staffing and inclement weather response efforts.



- Emerson Street Sidewalk Extension (south side) Woodside Drive to 67th Ave West
 - o Engineering design is in process. We are requesting a funding extension from PSRC.
- Regents Blvd (west) Grind & Overlay Alameda Ave to 67th Ave West
 - o The Council approved the engineering design contract on January 9th, 2024.
 - We are preparing a Notice to Proceed with WSDOT.
- South Orchard Street Grind & Overlay TIB Grant Funded
 - o Design is in process for construction in 2024.
 - o Fircrest staff and engineering consultants are continuing communications and coordination efforts with City of Tacoma staff.
- Electron and Contra Costa Intersection Improvement Legislative Funds
 - We received a \$153,000 appropriation of funds from the State Legislature.
 - All notifications and documentation have been provided to the Department of Commerce (DOC). We will present to the Council once the green light is received from DOC.
- Claremont Street Grind & Overlay TIB Grant
 - The City was awarded a Transportation Improvement Board (TIB) grant in the amount of \$677,409 for the Claremont Street Overlay project. The City's local grant match requirement is \$124,543.
 - o An amendment to the 6-year TIP will be presented to the Council on February 27th, following a public hearing on February 13th.

9. Black History Month Celebration

At its meeting on Monday, January 23rd, the Fircrest City Council issued a proclamation celebrating February as Black History Month. As part of its proclamation, the City Council invites Fircrest residents to join in this special observance through educational programs, celebrations, and activities highlighting Black and African American history.

A group of Fircrest neighbors have collaborated to bring a community-sponsored public event to the City of Fircrest. Hear from local leaders, network with neighbors, participate in a community art project, and meet some fantastic local Black-owned businesses. The event takes place on Sunday, February 25th, from 1:00 PM to 2:30 PM at the Community Center.

10. Westside Disposal Rate Increase

Westside Disposal has submitted a request for an annual rate adjustment as allowed by their contract with the City of Fircrest. If granted, the proposed rates would become effective March 1, 2024. This rate adjustment is made up of two parts: (1) A disposal fee adjustment at the LRI landfill, effective March 1, 2024. The disposal tip fee charged to Westside Disposal will change from the current \$171.23 per ton to \$174.84 per ton, an increase of 2.1%. (2) A CPI-based annual adjustment of 4.6%. The recycling commodity surcharge will also adjust from 0.83% to 0.94%. The City Council will take action on this item at the February 13th Council meeting.

11. Water/Sewer Assistance Program

Do you need assistance paying your water or sewer bill? The Low-Income Water Assistance Program (LIWAP) is designed to help qualified Pierce County residents pay off debts on water and sewer bills up to \$2,500. The Water/Sewer Assistance Program is currently accepting applications for assistance. Please note that this assistance program did not receive additional funding, so the program will end no later than March 31, 2024, or when funds have been exhausted.

To be eligible for assistance, applicants must meet specific income guidelines and live outside of the Tacoma city limits. For additional information, call 253-798-4328, visit <u>Water Assistance Program | Pierce County, WA</u>, or view the <u>LIHWAP program flyer</u>.

12. Tree Coupon Program

Well-placed and well-tended trees can enhance energy savings, stormwater management, air pollutant filtration, ambient air-cooling, and, of course, beauty in the landscape. In an effort to increase the tree canopy cover in Pierce County, the City of Tacoma and Tacoma Public Utilities have partnered together on the <u>Tree Coupon Program</u>.

Tree Coupons are for one-time use per residential property. Coupons are valid at participating tree retailers during the program season for \$30 off each five-gallon or larger tree for up to three trees per coupon/property. For purposes of the program, trees are woody plants whose height is greater than 15 feet at maturity. The last day to request a coupon for the 2023-2024 season is March 15th. Coupons must be redeemed by March 31st. Tree coupons can be requested online at 2023-2024 Tree Coupon Program or by contacting trees@cityoftacoma.org. 13. Connections & Conversations Series

14. After-School Activities – Tacoma Public Schools

Tacoma Public School and community partners have come together to offer fun, meaningful after-school activities to elementary and middle school students. Enrichment activities include sports, arts, and academic support. Registration closes on Saturday, February 10th, for Session 3, which runs from February 21st to April 12th, 2024.

- **Beyond the Bell** activities take place at all of Tacoma's elementary schools from 3:30 to 6:00 PM, Monday Friday. Program costs are \$96 per club/activity per session, with flexible pricing available for families who need financial assistance. Session 3 will feature Art Club, Bricks 4 Kidz, and Intramural Flag Football at Whittier Elementary, as well as Friday Fun Days. Students participating in Art Club will explore and share creativity through drawing, sculpting, painting, collaging, and crafting projects. Students will learn the fundamentals of S.T.E.M. education while participating in Bricks 4 Kidz by using Legos and model plans created by engineers and architects. - Club B activities take place at all of Tacoma's middle schools from 2:45 5:00 PM, Monday Thursday. Club B is free for all middle school students! 15. Community CPR Classes

February is <u>American Heart Month</u>, and this year, the <u>American Heart Association</u> is focusing on CPR. Cardiopulmonary resuscitation (CPR) is an emergency lifesaving procedure performed when the heart stops beating. The American Heart Association offers several free resources to learn CPR, including <u>Learn Hands-Only CPR videos</u> and related printable <u>Hands-Only CPR Resources</u>.

Additionally, the Tacoma Fire Department offers free community CPR classes to Fircrest residents. There is no age limit, but participants must be able to physically perform CPR for two minutes to receive a CPR card after completion of the course. The next class being offered is on Saturday, February 17th, from 8:30 – 11:30 AM at Fire Station 16 located at 7217 6th Avenue. Pre-registration is required by using the online CPR Pre-Registration form.

16. Kids 'N' Critters Weekends

Two kids ages 12 and under are FREE, with each paid adult general admission to Northwest Trek Wildlife Park each weekend in February, plus Presidents' Day. The discount is available only on tickets purchased at the onsite ticket window and does not apply to Wild Drives or Keeper Adventure Tours.
