## **Fircrest Parks and Recreation**

#### Fircrest Park Athletic Field Improvement Project

With financial assistance from the Washington State Recreation and Conservation office we recently replaced the natural grass at the south end of Fircrest Park. Our contractors were hard at work trying to beat the rain, restoring the natural grass athletic field at the south end of Fircrest Park last fall . This project's primary goals include achieving a uniform field surface and establishing an even stand of natural grass. The state is contributing \$158,515.00, which is 50% of the cost associated with this project. The fencing will remain in place until the spring after the contractor conducts their initial rounds of fertilizing and mowing on the new sod making things ready for spring and summer activities.

#### Whittier Park Master Plan

Over 50 community members actively participated in the second outreach session for the Whittier Master Plan held on December 14th at 6:30 PM in the Community Center. At this open house, the city's consultant, AHBL, introduced preliminary concepts for the Whittier Park Master Plan Project. The meeting was split into two parts: a quick presentation of the concepts, followed by an open house format session, with informational boards and staff present to answer questions and receive comments. During the open house, the public was encouraged to provide feedback on comment forms and sticky notes, and through a dot exercise. These invaluable contributions from the community will steer the creation of the Whittier Park Master Plan, ensuring it resonates with the wishes and desires of Fircrest residents. # PLANNING & BUILDING DEPARTMENT 2023 YEAR IN REVIEW

- Permit Coordinator Kristin Singh issued 214 permits. The majority were mechanical permits, followed by building permits, and plumbing permits.
- Passport Specialist Laura Thompson and Permit Coordinator Singh processed a staggering 2,307 passport appointment requests this year!
- Code Enforcement handled 31 cases total and was able to close 30 cases achieving a 97% voluntary compliance rate. A majority of the cases involved temporary yard signs/political signs.
- The Planning Commission continues to review Missing Middle Housing amendments. This is a state law requiring the City to plan for duplexes and accessory dwelling units in residential areas to increase housing supply.
- The 2024 Comprehensive Plan Update for Year 1 is complete. Year 2 will involve several opportunities for public participation. Please use the QR Code below to sign up for updates and stay involved.

# Public Works: 2024 UTILITY BILLING RATE INCREASES

On November 28, 2023, the City Council held a public hearing to receive comments on a Proposed Water Rate Adjustment. On December 12, 2023, the City Council adopted a 4.5% water rate increase. The new rates are effective February 1, 2024, and you will notice the increase on your April 2024 utility bill.

Rate adjustments help support water utility operation and maintenance costs and provide funding for capital improvements.

What can you expect? For Single Family Residential (SFR) within city limits, customers will notice a minimum increase on your water base charge of \$1.73 for each bi-monthly (2-month) billing cycle. Here is how that breaks down:

• The "Water Ready to Serve" fee will increase by \$1.73 (from \$38.49 to 44.22).

• Water usage is billed by cubic foot (cf) based on the following tiers and is not included in the minimum increase above. Water usage charges will increase as follows:

· Tier 1: (1 - 1,000 / cf)

§ Charges will increase by \$0.0005/cf (from \$0.0113 to \$0.0118/cf)

· Tier 2: (1,001 - 4,000 / cf)

§ Charges will increase by \$0.0008/cf (from \$0.0169 to \$0.0177/cf)

· Tier 3: (4,000 - + / cf)

§ Charges will increase by \$0.0013/cf (from \$0.0288 to \$0.0301/cf)
