2. February 27th, 2024 – Council Meeting Recap

Action items at the Tuesday, February 27th regular City Council meeting included:

- Approved liquor license renewal for Fircrest Golf Club.
- Held a Public Hearing to receive comments on an amendment to the City's 6-year Transportation Improvement Plan. There were no public comments.
- Discussed the Comprehensive Plan Update budget overage and the contract with BHC.
- Approved an Ordinance amending Fircrest Municipal Code Chapter 9.48 relating to controlled substances.
- Approved a Resolution amending the City's 6-year Transportation Improvement Plan.
- Reviewed the 2023 Year-End Financial Report.

4. Administration

Administration highlights include:

- City Manager Dawn Masko, Public Works Director Tyler Bemis, Project Coordinator Bob Jean, and Community Development Director Mark Newman continued to meet to discuss the sewer interlocal agreement. We are continuing to track down information from the Boundary Review Board regarding annexations as well as look for pre-annexation agreements referencing sewer.
- Acting City Clerk Arlette Burkhart met with a Senior Records Consultant from the WA State Archives Office on Monday, February 26th. They discussed record management methodologies, record clean-up, and long-term solutions. Clerk Burkhart will be meeting with the Records Consultant again within the next month for a Fircrest records management project kick-off.
- The Employee Safety Committee met on February 27th to approve their 2024 work plan, post-vehicle accident forms, emergency go-bags inventory, and employee rosters. The 2024 Safety Committee work plan includes establishing yearly training programs and a safety onboarding process for new employees, refining processes for fire drills, earthquake drills, and lockdown drills, and scheduling CPR training for staff.
- The City received eight public records requests this week for a total of 54 requests in 2024.
- Clerk Burkhart recently met with Risk Manager Blair Kok from Clear Risk Solutions. They
 discussed training opportunities, City facility reviews, playground inspections, and scholarship
 opportunities from the City's insurer, CIAW. CIAW offers grants for employees to utilize for
 risk management-related training. Clerk Burkhart has already received four training scholarships
 from CIAW. She will be meeting with Mr. Kok next month to conduct City facility reviews.
- City Manager Masko attended multiple meetings, worked with all departments on a variety of items, issued a grievance decision, assisted with grant applications, and updated the Budget Summary for the 2024 Adopted Budget Document.
- In the last 30 days, the City's website has had 18,033 page views from a total of 5,913 users. Sessions are down 3%, and users are up 1% from the previous 30 days.

5. Police Department Update

- Detective Roberts is continuing to work on the stolen John Deere tractor case. He has worked hours on this case, including two search warrants for evidence.
- We will be bringing forward a Sunnyside Jail contract soon. The daily rate is \$100 lower than our local misdemeanor jail options.
- We are working with the Puyallup Jail to do video arraignments instead of transporting prisoners to and from our Court. This will be safer for everyone involved and will reduce the workload.
- We recently learned that South Sound 911 and the radio system owners do not have a radio replacement fund for their partner agency radios. More to come on this issue.
- The Civil Service Oral Board interviewed one exceptional entry-level applicant on Thursday.
- Police Chief Ron Schaub is working through Lexipol's recent webinar regarding Undesirable Outcomes. The core principles from Lexipol's Root Cause Analysis are People, Policy, Training, Supervision, and Discipline.
- Fircrest officers responded to 200 calls for service for the period of 2/18/2024 2/25/2024, including 134 traffic stops, which generated 90 notices of infraction. Additional information is provided in the chart below.

6. Finance Department Update

- Finance Director Colleen Corcoran presented the 2023 Year-End Report at the February 27th City Council meeting.
- Finance Director Corcoran is working on the first 2024 budget amendment. She is also working with Finance staff and City Manager Masko to finalize the 2024 budget document.
- Following additional interviews this week, we are pleased to announce that we have hired a new part-time Accountant. She will be starting soon after completing a background check.

7. Parks & Recreation

Projects

- <u>Community Center Close-out</u> Parks & Recreation Director Jeff Grover and Finance Director Corcoran are working on closing out the Community Center project, including preparing a Resolution for City Council approval and compiling a comprehensive report on final financials.
- Whittier Park Master Plan An amendment to the AHBL contract will be presented to the Council at the March 12th Council meeting. This amendment would add a third community meeting to the Whittier Park Master Plan scope of work. Pending approval of the contract amendment, staff will commence outreach efforts for the third meeting. The Council's support and collaboration in this endeavor is appreciated and is invaluable to the success of the project.

Grants

Maintenance Lead Bryce Wakefield and Director Grover are currently researching potential
projects for the upcoming Recreation and Conservation (RCO) grant cycle. Aligning with our
strategy to finalize projects at Fircrest Park, they are focusing on enhancements to the three

youth baseball fields. The initial concept entails upgrading the fields with new backstops, dugouts, and improved hardscape, along with ADA access enhancements. They are diligently exploring this avenue to ensure the best possible outcome for our community. Grant applications are due on May 1st.

Recreation Programs

- Youth Basketball Parks & Recreation Director Grover expresses his gratitude to our Recreation Coordinator, Ryan Brown, for his outstanding efforts in coordinating a successful youth basketball season. With nearly 400 kids participating this season, the league has been a resounding success! We've received numerous positive comments from parents, highlighting the enjoyment and value their children have gained from the program. Thank you, Ryan!
- <u>Pee Wee Indoor Soccer</u> Registration is underway for the Pee Wee Indoor Soccer program. This is an instructional 6-week league introducing Pre-Kindergarten kids ages 4-5 years old to indoor soccer. Games and practices will be held on Saturdays, beginning on March 18th. - <u>Youth Baseball</u> Registration is just around the corner for another exciting season of youth baseball. 8. Planning & Building Update

- The City received five new code enforcement requests this week:
 - Two requests to investigate a barking dog at the 500 block of Buena Vista Avenue. Code Enforcement (CE) Officer Kristin Singh has contacted the property owner and provided a helpful handout to control dog barking. She is also coordinating with the Fircrest Police Department Community Service Officer to share information.

- A concern about overgrown blackberry bushes/vegetation creating a nuisance on a vacant lot on the 500 block of Ramsdell Street. CE Officer Singh has reached out to the property owner, who has agreed to trim the blackberry bushes.
- A concern regarding an over-excavated foundation along the 300 block of Harvard Avenue.
 CE Officer Singh has reached out to the building permit applicant for more information.
- A concern regarding unpermitted residential remodel work along the 1000 block of Brentwood Place. Permit Coordinator Singh is working with the property owner to pull permits for the job.
- Permit Coordinator Singh issued three new permits this week for residential mechanical and plumbing work.
- Permit Coordinator Singh has been hard at work processing City business licenses and transient merchant applications. She coordinated with the Parks & Recreation Department to exempt vendors who are participating in City-sponsored events and streamlined the process for application review.
- 2024 Comprehensive Plan Update
 - o Fircrest addresses should have received a postcard mailer asking for public comment on the Draft Plan, which will be accepted through April 30th. If you did not receive a postcard mailer or have questions, please contact Community Development (CD) Director Mark Newman at mnewman@cityoffircrest.net or (253) 238-4129.
 - The City has received 15 online responses so far, with the preliminary results indicating that the Vision Statement aligns with the community's wishes and that the public is satisfied with the City's public outreach efforts overall. While surveys may be submitted anonymously, not providing your contact information prevents City staff from engaging in important follow-up questions to address issues or concerns. Both paper and online survey data will be collected on a rolling basis and shared during City Council and Planning Commission meetings as well as on the 2024 Comprehensive Plan Update webpage.
 - O CD Director Newman submitted the <u>Draft Public Plan</u> to the Puget Sound Regional Council for their review prior to the formal certification process at the end of this year.
- We are pleased to announce that the Department of Commerce revised its grant award to the City for Level-2 EV Charging Stations from \$22,500 to \$30,000. Location and number of chargers is still being discussed to make sure they are placed in an area that works for the public.
- The Public Comment period on the 2024 Comprehensive Plan Update will kick off next week on Monday, February 26th. Please look out for a mailer in your mailbox with more information on how to review the draft plan and submit comments. Hard copies of survey materials are available at both City Hall and the Community Center. Visit the 2024 Comprehensive Plan Update website to learn more!
- CD Director Newman applied on the City's behalf for the AARP Community Challenge Grant Program. The City requested \$50,000 to install approximately 15 new ADA-accessible benches and picnic tables throughout City parks in preparation for next year's Centennial Celebration.
- CD Director Newman met with City Manager Masko, Project Coordinator Bob Jean, and Public Works Director Tyler Bemis on sewer service options for the City's northwest corner.
- The Planning & Building Department received the Prose project site plan design review resubmittal and will begin processing it for review.

The City of Fircrest was awarded bronze-level EVAL (Electric Vehicle Adoption Leadership)
certification for its commitment to investigating clean energy solutions like electric vehicle
charging stations.

9. Public Works Update

Public Works is operating under winter hours from 8:00 AM to 4:30 PM.

Highlights include: (in addition to routine daily tasks)

Emergency Management Training

• We are starting the process for all Public Works staff to complete National Incident Management System (NIMS) training through FEMA. These are free training courses and provide the framework for responding to large-scale emergencies and disasters.

Utilities - Water, Sewer, Streets, and Stormwater

- One pump is currently being repaired at the Commons lift station due to jammed wastewater debris and worn brass ring screws. Upon return of the repaired pump, the opposite pump will be pulled and inspected for repair needs.
- The old bucket truck was posted for sale on Monday, February 26th, with a minimum sale price set at \$30,500. Sealed bids are due by Monday, March 11th.

Maintenance – Parks & Facilities

- The City Hall fire monitoring equipment installation is approaching completion.
- This week marked the first mowing of the grass at Fircrest Park. The crew also performed cleanup work and repairs around picnic tables, park benches, and baseball fields.
- A water leak was repaired at the pool on a domestic water line. Staff is currently working on the leak adjustment.

Project Updates

- Well #7 (Claremont)
 - We received an exorbitant bid from the first contractor that we communicated with.
 - o A second contractor provided a bid for a complete rebuild and is preparing a bid for a partial rebuild within the constraints of the structural assessment, if possible.
 - o We are continuing to seek other bids utilizing the MRSC Small Works Roster.
- Fircrest Park Maintenance Facility Structure Upgrade
 - o Staff are meeting to finalize the size, style, wants versus needs, and timeline.
 - We will seek multiple bids utilizing the MRSC Small Works Roster or issue a Request for Proposals (RFP).
- 44th Street West & 67th Ave West Lift Station Upgrade
 - o Equipment submittal review of the generator and SCADA cabinet is in progress.
- Storm Water Pre-Treatment Outfall Grant Project Emerson Street & Estate Place
 - o Final close-out Progress Reports and Payment Requests are in progress.
- Regents Blvd (west) Grind & Overlay Alameda Ave to 67th Ave West
 - o We are working with WSDOT on preparing a Notice to Proceed.

- AMI Water Meter Exchange Program
 - o Meter exchanges are in progress, with program completion currently at 52%.

- Emerson Street Sidewalk Extension (south side) Woodside Drive to 67th Ave West
 - We are requesting a one-year funding extension from PSRC while the engineering design is in process.
- South Orchard Street Grind & Overlay TIB Grant Funded
 - o Design is in process for construction in 2024.
 - We continued communication and coordination with City of Tacoma streets, signal, and ADA staff.
- Electron and Contra Costa Intersection Improvement Legislative Funds
 - We are still awaiting the green light from the Department of Commerce (DOC) and will bring forward approval paperwork to the Council once it is received.
- Claremont Street Grind & Overlay TIB Grant
 - The City was awarded a Transportation Improvement Board (TIB) grant in the amount of \$677,409 for the Claremont Street Overlay project. The City's local grant match requirement is \$124,543.
 - O The Council adopted an amendment to the 6-year Transportation Improvement Plan (TIP) following a public hearing on February 27th. The amendment added the Claremont project to the TIP, allowing the City to utilize Real Estate Excise Tax (REET) proceeds as local grant match funds.
 - o Grant acceptance documents, including a Fuel Tax Agreement, will be presented to Council on March 12th.

10. Masko Park Improvements

Since early 2021, Public Works and Parks staff have been actively involved in discussions aimed at enhancing George Masko Park. New benches at the park entrance, funded by the Masko family, were recently installed, and painting and planting have occurred. These improvements have been well-received by the community. The family is now proposing the installation of a swing set, similar to a playset that was in the park years ago and has committed to raising \$25,000 for this project.

Fircrest staff supports the Masko family's vision to enhance this park, providing additional recreational opportunities for residents while preserving its natural beauty. Next steps include reviewing the proposal, planning the project to consider factors such as site preparation, safety regulations, and ongoing maintenance, providing administrative support to facilitate the project, encouraging community involvement in the project, and supporting fundraising efforts. Staff will keep the Council informed about the project's fundraising efforts and any City support needed.

11. State Building Code Update

On March 15, 2024, the City of Fircrest will adopt the 2021 State Building Code as required by the State Building Code Council. Any permits or applications submitted prior to March 15th will be reviewed under the 2018 Code. Any applications submitted on or after March 15th will be reviewed using the 2021 Code. This information has been posted on the <u>Permit Center's webpage</u>. The amendments to the Code can be found on the <u>State Building Code website</u>.

12. Passing of Denny Richards

Our condolences to the family of Denny Richards, who passed away this week. Mr. Richards was the Fircrest City Manager from September 1995 to November 1999. In addition to the City of Fircrest, his long tenure in City government included the Vancouver Police Department, Kelso, Sammamish, Long Beach, Liberty Lake, Battle Ground, Jefferson County, Gig Harbor, and SeaTac.

13. Pierce Transit Service Changes

There are many changes coming to Pierce Transit at the end of March. Bus routes and how customers ride them will be adjusted to make the most of the resources available. Changes include schedule improvements to most bus routes, launching an on-demand service zone in Gig Harbor, and adding a high-capacity transit service between Spanaway and downtown Tacoma.
