- We absolutely love having Fircrest park for community events and feel that Whittier park would benefit from multi use fields, sports courts and trail systems for outdoor activities. Drainage will solidify year round use for the community.

- I also love my memories of Fircrest fundays, fishing in the old pool and the tree lighting
- I'm not a big fan for a dog park for my dog however I think it might help for the people who continue to crowd the park with their dogs off leash
- Please add a dog park to Whittier Park. It doesn't need to be huge. An agility course would be fantastic!
- I would like for Whittier to remain multi-functional and "comfortable" for both passive and active recreation. That is, when sports aren't happening it should still be a good place to throw a frisbee. Too many parks feel too full or too programmed to just play.
- What this town needs is a monorail.
- There is a weird pushback against adding things like a dog park or community garden, both things that are meant to bring people together. I'd like to hear why it is better to just keep property the city owns vacant or under utilized instead of adding another attractive feature.
- This may be self evident, but the most critical task for Whittier park seems to be fixing the drainage issue on the east side. It's a swamp most of the year, and prohibits many activities in that field. Referencing the question about the Whittier Park Plan, I have seen nothing other than that a planning meeting is going on to create a plan. The communication about planning meetings is sufficient. Thank you.
- Used to walk more regularly to Whittier and visit Fircrest parks more frequently.
- Wish there were more activities/events for adults. They need to be better advertised/announced.
- Do not allow Whittier to swap our precious land





- Also need to address people keeping dogs on leashes. Too many people let them run unleashed at the park and it's incredibly annoying. Fields are for the kids not your dog.
- In general I think Fircrest parks are awesome, but I'm excited to see some new opportunities at Whittier Park.
- Someone needs to address all the homeless in Fircrest it's becoming scary and is problematic
- Considering adding a dog park on the vacant land next to the tot lot, or dedicated pickleball courts.
- I would like to see a small playground that the siblings of soccer/baseball players could play on while waiting on the sidelines. I would also like the (drainage?) channels filled in between the tennis courts since it is a tripping hazard.
- I like the serenity of the park and its open space. Please no land swap. (we don't need a school to be built in the park.) It would spoil the open space and view.
- Thank you so much for encouraging community input and great communication!
- Please consider offering alternatives to typical team sports and tennis, many children and adults would love other options close to home. Seeing kids out exercising while riding their scooters on a mini ramp or a 40 year old getting off their butt to ride a ramp would be a fantastic option. Pump tracks for mountain bikes/box bikes/ skateboards can be fairly compact and offer a fantastic opportunity for bicycle skill building and exercise. Tacoma public schools and Fircrest need to have express the speed limit around the neighborhoods. I live on on Forrest Park Dr and it seems that they need to speed to able get up the hill and not bother to brake until Conta Costa. More stop signs like Ramsdell and Conta Costa or speed bumps or mounds.

- We received a brochure in the mail from Fircrest Parks and Recreation, which talks about the next public meeting on December 14, Saturday at 6:30 PM. To begin with December 14 is a Thursday. Scheduling meetings for the public at this time of the year in advance of Christmas is problematic for people to be able to attend, certainly a Saturday meeting is almost to people we don't want you to attend, because you're likely going to be doing something else. Even if the correct day is Thursday, conflict will inevitably arise. This public meeting is important and should be taking place after the first of the year .
- Fircrest needs to deal with the homeless problem that surrounds us. We should be humane and compassionate but firm. More policing, especially at night.
