# 5. April 9th, 2024 – Council Meeting Recap

Action items at the Tuesday, April 9<sup>th</sup> regular City Council meeting included:

- Held a Public Hearing on the 2024 Stormwater Management Program Plan.
- Adopted the 2024 Budget Amendment #1 Ordinance.
- Approved a Resolution authorizing the Pierce County System Access & Use Agreement for police mobile and portable radios.
- Approved a Resolution authorizing an Interlocal Agreement with Sunnyside Jail.
- Approved a Resolution authorizing a grant agreement with the WA State Department of Commerce for the Electron Way/Contra Costa Avenue Intersection Improvement project.
- Approved a Resolution authorizing a professional services agreement with KPG Psomas for engineering design services for the Claremont Street Grind & Overlay project.
- Approved a Resolution authorizing a grant agreement with the WA State Department of Commerce for a Climate Planning Grant.

#### 6. Administration Update

Administration highlights include:

- Acting City Clerk Arlette Burkhart and Accountant Megan Ryan met with the pool manager to discuss shared responsibilities and best practices for the hiring of seasonal staff.
- Acting Clerk Arlette Burkhart is continuing to gather information to apply for WA
  Transportation Improvement Board Complete Streets Early Opportunity funding to complete the
  entire intersection of Electron Way and Contra Costa Avenue. If awarded, this funding, in
  combination with the Department of Commerce grant, would replace all out-of-compliance curb
  ramps to bring them to ADA standards.
- City Manager Dawn Masko worked with Police Chief Ron Schaub to finalize a draft Memorandum of Understanding (MOU) regarding police schedules. The draft MOU will be forwarded to the Police Guild and, if ratified, brought forward to the City Council for consideration.

- City Manager Masko, City Attorney Bob Zeinemann, Project Coordinator Bob Jean, and Community Development Director Mark Newman met with the City's internal team regarding Prose Project developments.
- Acting Clerk Burkhart and Community Service Officer John Troung have been inventorying records and organizing them according to the retention schedule prescribed by the Washington State Archives.
- City staff continue to communicate with Facebook Meta to consolidate the City's social media
  pages under one Business Meta Suite. Special thanks to Administrative Assistant Sierra Lee for
  her continued efforts with this undertaking.
- Acting Clerk Burkhart is coordinating dates for Council photos with the City's photographer.
- City Manager Masko upgraded the Fircrest Civil Service Rules and Regulations into a searchable PDF file as part of an ongoing effort to continue digitizing City policies, procedures, and records.
- Acting Clerk Burkhart and Public Works Director Tyler Bemis are continuing discussions on grant opportunities regarding Pedestrian Safety.
- The City received seven public records requests this week for a total of 86 requests in 2024.
- City Manager Masko attended the AWC 2024 Legislative Session recap webinar.
- In the last 30 days, the City's website has had 20,276 page views from 6,901 users. Sessions are up 12%, and users are up 11% from the previous 30 days.

#### 7. Finance Department Update

- Finance Director Colleen Corcoran is continuing to work on the Annual Report, which must be submitted to the WA State Auditor's Office by May 29<sup>th</sup>.
- Part-time Accountant Wanda Wells continued her training. She is doing a great job at filling in for Accountants Julie Dunbar and Megan Ryan this week.
- Finance Director Corcoran is continuing her work on updating 2023 grant files. This information
  will be used for the Annual Report and to ensure that all grant revenue is billed and received.
  Acting Clerk Burkhart has created a tracking spreadsheet that will be updated to include financial
  tracking and used citywide.
- The City's network and phone system will be down on Thursday, May 9<sup>th</sup>, for planned upgrades. We will work to ensure that adequate notice is provided via our website, social media, and signage. There will also be a recorded message on City phone lines on May 9<sup>th</sup> informing the public that the City is undergoing planned maintenance on its phone system and network, that all City buildings will be open during regular business hours, and that some services may be unavailable due to the maintenance. All systems are scheduled to resume on May 10<sup>th</sup>.

#### 8. Police Department Update

- Police Chief Ron Schaub attended the Kiwanis Terrific Kids Assembly at Wainwright Intermediate School.
- Officer C. Roberts completed the EVOC (Emergency Vehicle Operations) Instructor course.
- Chief Schaub conducted an introductory interview with an out-of-state lateral officer applicant. A Civil Service Oral Board for two candidates will be scheduled within the next few weeks.

- Chief Schaub attended the Public Safety Communications Operations Committee meeting at South Sound 911 this morning.
- There were 962 total calls for service for the month of March.
- Fircrest officers responded to 176 calls for service from 3/31/2024 to 4/07/2024, including 157 traffic stops, which generated 104 notices of infraction. The chart below provides additional information.

#### 9. Planning & Building Update

- The Planning & Building Department is currently short-staffed as it searches for a new Permit Coordinator/Assistant Planner/Code Enforcement Officer. We appreciate your patience during this transition.
- Please note that our permitting system and phone system will be unavailable on Thursday, May 9<sup>th</sup>, for scheduled network maintenance.
- Interviews were held for the Permit Coordinator/Assistant Planner position this past Monday. The top candidate is undergoing a background check, and we hope to extend an offer soon.
- Staff continue to run day-to-day operations, issuing permits, routing inspections, and answering phone calls and emails from the public regarding zoning, ADUs, and business licensing.
- CD Director Mark Newman completed the planning and engineering reviews for a new single-family residential home and ADU along the 1200 block of Arondale Drive.
- City staff met with Kimley-Horn & Associates for a Middle Housing kick-off meeting. The meeting included discussion on the development of a public participation plan, community engagement strategies, and scheduling a public open house this summer. Stay tuned for more information in the coming months.
- There is still time to submit feedback for the <u>2024 Comprehensive Plan Update</u>. Please submit your feedback either <u>online</u> or in person at City Hall or the Community Center no later than April 30<sup>th</sup>, 2024.

- The City received two new code enforcement requests this week:
  - Two requests regarding transient merchants and commercial canvassing without City of Fircrest business licenses. Staff contacted the businesses to inform them of the licensing requirements.
- The City continues to monitor existing complaints and requests:
  - o Concern over multiple inoperable vehicles, garbage accumulation, and burning of trash along the 200 block of Regents Blvd.
  - Concern over an RV parked long-term in the City's right-of-way along the 400 block of Harvard Avenue. The owner committed to having the RV towed by April 12<sup>th</sup>. Staff will follow up this coming week.
  - Concern over the accumulation of trash, food waste, and overgrown vegetation along the 200 block of Alameda Avenue. This is in addition to an existing concern regarding an RV being lived in within a single-family zoning district.
- CD Director Newman updated the City Council on the Level 2 EV Charging Grant and TPU rebate program and provided associated cost estimates.
- CD Director Newman attended the AWC's 2024 Legislative Session recap webinar.
- Washington State's Arbor Day was held on April 10<sup>th</sup> this year. The WA State Department of Natural Resources (DNR) has released an Arbor Day coloring book. #### 10. Parks & Recreation Update

#### Park Projects

- <u>Community Center</u> Green Leaf Landscaping has replaced the trees at the Community Center, which Kassell wouldn't replace. Green Leaf did an excellent job matching the size and species of each tree. Thank you Maintenance Lead Bryce Wakefield, for helping coordinate this project.
- <u>Fircrest Park Athletic Field Improvements</u> KBH Construction recently completed the removal of the fence at Fircrest Park, and the newly laid sod is looking fantastic. While the project is nearing completion, there are still a couple of punch-list areas that need attention. Additionally, we will be focusing on addressing the lighting in the next few weeks, as there are a few lights that are not consistently working. Thank you for your continued patience and support as we work to enhance Fircrest Park.
- Whittier Park Master Plan DataBar has assured us that the postcard for the upcoming meeting on April 25<sup>th</sup> will be mailed out to all Fircrest households by April 19<sup>th</sup> at the latest. Furthermore, advertising for the meeting started this past week on our website, social media, and the readerboard. ABHL is excited to present its two concept master plans and actively engage with the community during the upcoming meeting. The meeting is scheduled to take place on April 25<sup>th</sup> at 6:00 PM in the Names Family Foundation Gymnasium.

# 11. Public Works Update

Public Works' current winter operating winter hours are 8:00 AM to 4:30 PM.

Highlights include: (in addition to routine daily tasks)

#### Administration

Your patience is appreciated as Public Works is currently short-staffed and is working to fill the vacant position of Public Works Office Coordinator. Four candidates have been selected to participate in the interview process, which is tentatively scheduled for April 16<sup>th</sup>.

#### Utilities - Water, Sewer, Streets, and Stormwater

- Maintenance and repairs are occurring on the fluoridation systems at all Well sites.
- The Alameda Lift Station's repairs, including the replacement of an impellor and wear rings on a pump, are scheduled for April 19th. These repairs should improve pump efficiency.
- The replacement pump for The Commons Lift Station will not arrive for at least 10-12 weeks.
- The replacement fire hydrant for the damaged one at The Commons is estimated to arrive in early May.
- The fire hydrant at El Dorado and Regents Blvd. is scheduled for repairs next week. The repairs were rescheduled because a hot tap of the main is necessary.
- "Sidewalk closed" barricades are in place near the Claremont rock wall failure site. The property owner is currently performing the repairs and continues to keep Public Works informed.
- The James G. Murphy Co.'s <u>online auction</u> closed yesterday. We are hoping to hear soon what the auction results were for our Bucket Truck.

#### Maintenance – Parks & Facilities

- Irrigation repairs are underway in preparation for summer watering at all City parks.
- Staff continued working on pool preparations for the upcoming 2024 season.
- Staff repaired picnic tables at Fircrest Park.

#### **Project Updates**

- Claremont Street Grind & Overlay TIB Grant
  - o Council approved the design services agreement on April 9<sup>th</sup>.

- Well #7 (Claremont)
  - We received one bid from the five contractors who were invited to bid on the project from the MRSC Small Works Roster. The construction bid award will be brought forward on April 23<sup>rd</sup> for Council approval.
- Fircrest Park Maintenance Facility Structure Upgrade
  - o Bids for this project were due today. Following bid review, a contract will brought forward for Council approval at an upcoming Council meeting.
- 44<sup>th</sup> Street West & 67<sup>th</sup> Ave West Lift Station Upgrade
  - The contractor is procuring equipment and materials in preparation to start construction and is coordinating tree removal to begin the site prep process.
- Storm Water Pre-Treatment Outfall Grant Project Emerson Street & Estate Place
  - o Final close-out Progress Reports and Payment Requests are in progress.
- Emerson Street Sidewalk Extension (south side) Woodside Drive to 67<sup>th</sup> Ave West
  - o Engineering design is in process.
- Regents Blvd (west) Grind & Overlay Alameda Ave to 67<sup>th</sup> Ave West
  - We are working with WSDOT to prepare a Notice to Proceed.
- AMI Water Meter Exchange Program
  - o Meter exchanges are in progress, with program completion currently at 54%. No meters were exchanged this week due to meter readings and staff training.

  - The design is in the process of construction in 2024.
  - Communication and coordination with City of Tacoma staff are continuing, with a joint coordination meeting occurring on April 5<sup>th</sup>.
- Electron and Contra Costa Intersection Improvement Legislative Funds
  - o City Council approved the Commerce (DOC) grant agreement on April 9<sup>th</sup>.
  - We are continuing to explore options to apply for additional funds from TIB.
