Below is the weekly overview of upcoming events, meetings, and other items of interest for the City. The update includes reports from City departments on various programs, projects, and achievements.

1. Planning Commission Opening

The City is seeking interested residents for appointment to the <u>Planning Commission</u>. This 6-year voluntary position is an opportunity for citizens to play a pivotal role in the development and future vision of Fircrest. Eligible applicants must be residents of Fircrest and registered voters. Letters of interest, along with a resume (optional), are due to the City Clerk no later than 5:00 PM on Thursday, May 23, 2024. Appointments are made by the Mayor and confirmed by the City Council. 2. Finance Director Recruitment

As a result of the impending retirement of long-time Finance Director Colleen Corcoran, the City of Fircrest is actively seeking a Finance Director. This position provides leadership to the Finance Department and is responsible for the City's financial operations. The position is open until filled, with the first review of applications on June 4th. 4. Administration Update

Administration highlights include:

• The City of Fircrest is pleased to announce that we have been recognized as a 2024 WellCity Award recipient. Fircrest was one of 117 cities that earned this distinction for 2024. The WellCity Award is given annually by the Association of Washington Cities (AWC) in recognition of AWC members who achieve quality standards in employee health promotion. By earning this award, the City receives a 2% premium discount on our medical premiums for 2025.

- The enthusiastic Centennial Celebration Committee met today and had great discussions on the Centennial Logo, events, historical items, beautification initiatives, and potential sponsorships. A Centennial website will be launched soon to provide information on this exciting celebration and how people can get involved. The next meeting will be held in late June.
- Acting City Clerk Arlette Burkhart and Community Service Officer (CSO) John Truong attended
 the Washington Association of Public Records Officers (WAPRO) virtual spring conference this
 week. Presentations included case law updates, court public records, personnel records, and
 transferring agency records to the State archives. Acting Clerk Burkhart and CSO Truong will
 meet next week to continue discussions on City record management and best practices for
 responding to public records requests.
- City Manager Dawn Masko spent a substantial amount of time finalizing and posting recruitment materials for the Finance Director position.
- Acting Clerk Burkhart and Police Chief Ron Schaub met with Civil Service Commissioner
 Phillip Wilson to discuss proposed amendments to the Civil Service Rules. Commissioner
 Wilson has a wealth of knowledge of Civil Service systems from his tenure with the Department
 of Natural Resources.
- Mayor Pro Tempore Nikki Bufford, Councilmember Jim Andrews, and City Manager Masko were appointed by the City Council as their voting delegates for the Association of Washington Cities 2024 annual board meeting, which will be held in June at the annual conference.
- City Manager Masko is working on a market compensation study for non-represented positions.
- The City received five public records requests this week for a total of 116 requests in 2024.
- In the last 30 days, the City's website has had 21,255 page views from 6,452 users. Sessions are down 1%, and users are down 6% from the previous 30 days.

5. Finance Department Update

- Finance staff continue to work on the Annual Report, which is due to the State by May 29th.
- The month-end reports for March and April are on hold until the State reports are filed.

6. Police Department Update

- Police Chief Ron Schaub and Civil Service Examiner Arlette Burkhart met with Civil Service Commissioner Phillip Wilson to discuss the proposed Civil Service Rules updates in depth. Commissioner Wilson offered valuable insight into some of the language changes.
- An out-of-state candidate passed the Civil Service oral board this past week and will now move forward into the preliminary background process.
- Community Service Officer John Truong attended the WA Association of Public Records Officers (WAPRO) records training this week.
- The planning process for National Night Out (NNO), which will be held on Tuesday, August 6th, has begun. As planning progresses, more details will be provided.
- Some of our newer officers are being scheduled to attend the Pierce County regional active shooter training exercise.
- We are examining our department's records retention process in relation to <u>RCW 10.122.140</u> —
 Handling and Preserving Electronic Recordings of Custodial Interrogations.

- Chief Schaub attended the South Sound 911 Board Meeting and the South Sound 911 Regional Steering Radio Communications Group meeting this week.
- Chief Schaub and other stakeholders attended a virtual meeting with Representative Mari Leavitt to discuss the difficulties that small police agencies face in hiring and retaining officers. The attendees discussed ways to assist small agencies with recruitment and retention. 60% of police departments in Washington State have 15 or fewer officers. The issues and concerns discussed were echoed by the Washington Association of Sheriffs & Police Chiefs (WASPC), Washington Council of Police & Sheriffs (WACOPS), Fraternal Order of Police (FOP), and the Chair of the House Public Safety Committee, State Representative Roger Goodman.
- Fircrest officers responded to 177 calls for service from 5/5/2024 to 5/12/2024, including 103 traffic stops, which generated 61 notices of infraction. The chart below provides additional information.

7. Planning & Building Update

- The new Middle Housing webpage has launched! Please take a look at it and sign up to stay involved. Remember to attend the June 17th City Council study session, where our consultant will present on the Middle Housing strategy for Fircrest.
- The Planning & Building Department is currently short-staffed as it searches for a new Permit Coordinator/Assistant Planner/Code Enforcement Officer. We appreciate your patience during this transition.
- Community Development Director Mark Newman, Finance Director Colleen Corcoran, and Parks & Recreation Director Jeff Grover interviewed three applicants this week for the Permit Coordinator/Assistant Planner position. We intend to bring the top candidate in for a second interview next week.
- CD Director Newman provided City Manager Masko with an update on Planning and Buildingrelated topics from the May 13th AWC Legislative Bulletin.

- We continue to be busy issuing over-the-counter (OTC) building, mechanical, plumbing, and reroofing permits. Applicants are receiving same-day or one-business-day turnaround time for OTC permits.
- CD Director Newman is working with the Department of Commerce on a contract amendment in order to receive our Year 2 grant reimbursement for the Comprehensive Plan Update grant before the June 15, 2024, deadline.
- The City received one new code enforcement request this week:
 - Oconcern over an abandoned home along the 500 block of Berkeley Avenue with overgrown vegetation, litter, and broken windows. City staff inspected the property and confirmed it was vacant. Staff reached out to the property owner using multiple methods to establish contact and issued a notice of violation.
- The City continues to monitor existing complaints and requests, but due to short-staffing, we have been unable to follow up on several requests.
- CD Director Newman met with Jason Gauthier, Manager of South Sound Housing Affordability Partners (SSHA³P), and Council Committee Liaisons Hunter George and Brett Wittner to discuss the SSHA³P 2025 work plan and budget.
- City staff meet with Kimley-Horn to discuss the Middle Housing draft public participation plan.
- An architectural firm is under contract to design a proposal for the Orchard Street Properties
 (commonly referred to as the Bourgaize Property.) The architect will be meeting with City staff
 next week to discuss draft design proposals and examine issues related to ingress/egress and site
 design/topography.

8. Parks & Recreation Update

Park Projects

• Fircrest Park Courts – This week, the Public Works Maintenance team, along with Parks & Recreation Director Grover, retrieved acoustic mats purchased from the Kitsap Humane Society. We purchased 18 mats at \$50 each, totaling \$900. The mats, measuring 9 feet in height and 4 feet in width, are being cleaned by the Public Works team, utilizing a pressure washer due to prolonged exposure to the elements. Next week, they will be affixed to a 70 linear foot area along the back of the fence. Prior to installation, additional decibel meter tests will be conducted, and ongoing decibel testing will continue post-installation.

9. Public Works Update

Public Works' current summer operating hours are 7:00 AM to 3:30 PM.

This week's highlights include:

Utilities - Water, Sewer, Streets, and Stormwater

- Summer hire applications are being reviewed, with plans to hire 2 4 Utilities summer hires. The job posting will remain open until all positions are filled.
- It was determined that the soft start was not the issue with the pump at Wellhouse #9. The contractor pulled the pump on May 16th to inspect the column, wiring, pump motor, and check valve. Repairs or replacements will be scheduled following the outcome of the inspection.
- Additional sweeping was performed on main arterials.
- Utility Foreman Jeff Davis met with The Lookout developer and City of Tacoma staff regarding ADA work to be performed at Stanford Street and South Orchard Street. They also discussed potential traffic impacts when the contractor grinds and paves the intersection, which is tentatively scheduled for May 29th & 30th.
- Utility Foreman Davis met with Xfinity regarding new fiber installation from Princeton Street at Berkeley Avenue to South Orchard Street for service to The Lookout.
- The replacement pump for The Commons Lift Station is expected to arrive by the end of June.
- We are awaiting final asphalt patching at the site of the damaged fire hydrant at El Dorado and Regents Blvd., which was repaired in mid-April.
- We are still seeking applicants for our utility summer hire positions. Information and the online application link is available on the City's <u>Employment Opportunities</u> webpage. The job posting will remain open until all positions are filled.

Maintenance – Parks & Facilities

• Sound-dampening mats were picked up from the Kitsap Humane Society this week. Facilities staff are cleaning and prepping them for installation at the Fircrest Park Courts next week.

 - o The notice to proceed to commence construction is being prepared.
- Fircrest Park Maintenance Facility Structure Upgrade
 - o Staff are preparing a Request for Proposals for posting on Monday, May 20th.
- 44th Street West & 67th Ave West Lift Station Upgrade
 - o The contractor is procuring equipment and materials in preparation to start construction, with Public Works staff continuing to review material submittals.
 - o Tree removal is being coordinated to begin the site prep process.
- Stormwater Pre-Treatment Outfall Grant Project Emerson Street & Estate Place
 - o Final close-out Progress Reports and Payment Requests are in progress.
- Emerson Street Sidewalk Extension (south side) Woodside Drive to 67th Ave West
 - o Engineering design is in process.
- Regents Blvd (west) Grind & Overlay Alameda Ave to 67th Ave West
 - o We are working with WSDOT to prepare a Notice to Proceed.
- AMI Water Meter Exchange Program
 - o Meter exchanges are in progress, with program completion currently at 57%.
