#### Public Works: Property Owner Vegetation Maintenance

Property owners are responsible for maintaining private trees and all other vegetation in the right of way next to their property. It is a violation of Fircrest Municipal Code 22.62.005 to neglect overgrown vegetation and private trees that obstruct the right of way. Furthermore, overgrown vegetation and private trees create accessibility barriers for people with disabilities and therefore non-compliant with the Americans with Disabilities Act (ADA).



#### **Guidelines for Keeping Your Right of Way Clear**

Sidewalks:

- Trim back limbs and vegetation from the edge of the sidewalk.
- Ensure a clearance of at least eight feet above the sidewalk to prevent obstruction an provide safe passage for pedestrians, including those using mobility aids.

#### Streets/Alleys:

- Trim back limbs and vegetation from the curb or edge of the payment.
- Maintain a vertical clearance of at least 14 feet above streets and alleys to allow for the safe passage of vehicles, including emergency and service vehicles.

General:

- Regularly inspect and trim or remove vegetation that blocks signal lights, traffic signs, and pedestrian signs to ensure they are clearly visible to both drivers and pedestrians.
- Remove any fallen branches or debris from the right of way promptly to prevent hazards.

## **Planning & Building**

The sunny weather means more businesses are out soliciting services. The City of Fircrest requires a transient merchant registration in addition to the general business license for doorto-door solicitors, peddlers, or canvassers. Exemptions are:

- Garage sales, yard sales, bake sales, occasional parties or other isolated sales. These are limited to no more than four such sales per year.
- Minors engaged in babysitting, delivery of newspapers, lawn mowing, car washing, and similar activities.
- Nonprofit organizations (proof provided) are required to apply for a city business license but are exempt from the fee.

As temperatures rise, we are making every effort to meet the growing demand from our community members. Pool capacity may differ between sessions and is set by pool management with an emphasis on swimmer and patron safety. Safety is of utmost importance to us, and pool management evaluates several factors during each swim session, including the swimmer-to-guard ratio, obstructions to vision, and the capabilities of the swimmers using the pool.

The public open swim sessions and swim lessons occupy a significant amount of pool time. To offer something for everyone, we have filled a few of the gaps with great programming, including our Water Aerobics classes taught by two of our dedicated senior lifeguards. Water Aerobics classes take place from 8-9 am on Tuesdays and Thursdays.

As always, our dedicated lifeguards and staff will be present to ensure your safety and provide any assistance you may require during your visits to the Edwards Family Aquatic Center. We kindly ask everyone to follow the pool rules and guidelines, including appropriate swimwear, parental supervision for children, and respectful behavior towards fellow swimmers.
