9. COMMISSIONER COMMENTS/ROUNDTABLE UPDATES/STAFF UPDATES

A. Brief Introduction of New Planning Commissioner Schonger

Commissioner Schonger introduced himself to the Planning Commission. Commissioner Schonger moved to the U.S from Germany in 2000 and has been a resident of Fircrest since 2008. He has been an active member in the community, having served on the steering committee for the Fircrest pool. He is a trained pipe organ builder and has recently obtained his real estate license.

B. Discussion about the July Middle Housing Open House

Commissioner Lane commented that July's public Middle Housing Open House did not go from 6-9 pm as advertised and questioned why it was cut short without being announced as there were other members of the public still wishing to attend. Director Newman responded that by 7:30 pm there were no members of the public left present, so staff and consultants decided to end the meeting early. Director Newman acknowledged that the early ending should have been posted. Director Newman acknowledged the other challenges of the Middle Housing Open House and assured Planning Commission that future public meetings and open houses will have better coordination and design. Commissioner McVay commented that meetings with the public need to be better planned and coordinated.

C. Update on the Upcoming Middle Housing Survey

Director Newman updated Planning Commission on the status and goals of the public middle housing survey. Director Newman confirmed that a physical survey will be mailed to residents and available online in addition to being advertised on the reader board and city website.

D. Discussion about Public Notification and City Communication with Residents

Commissioner McVay commented that city communication with residents about events and emergencies needs to be significantly improved, especially for those residents who are not connected

to the internet. Chair Schultz followed up that city communication needs to be improved particularly when setting ground rules for meetings. Director Newman acknowledged the feedback and how it will guide meetings with the public going forward. Director Newman also commented that City Council and the City Manager are working to formulate a city communication plan.

E. Overview of the August 19th City Council Study Session

Director Newman provided an overview of the Hanover Company mixed-use development project presentation from the August 19th City Council Study Session. Director Newman gave a brief status update of the project. Director Newman provided an overview of the sign-code discussion and interpretation determination from the August 19th City Council Study Session. Planning Commissioners had a brief discussion about sign codes and encouraged staff to enforce the sign code.

F. Existing Middle Housing Stock in Fircrest

Assistant Planner Kolostyak is working on compiling a list of the city's existing middle housing stock. Assistant Planner Kolostyak will present the findings to Planning Commission in either September or October.

G. Comprehensive Plan Updates

Director Newman is continuing to edit the new Comprehensive Plan. Director Newman hopes to have the Comprehensive Plan ready for Planning Commission Public Hearing in October and City Council Public Hearing November to ensure adoption in December to meet the deadline.

H. SSHA³P – Universal Design Policy Recommendations

Director Newman presented the Universal Design Policy Recommendations packet from SSHA³P. Vice Chair Ferguson provided comments on the specifics of universal design standards as well as the practical implications of requiring universal design. As a member of SSHA3P, Vice Chair Ferguson is working on understanding the cost implications of these requirements to new construction and is preparing case studies on the topic for a future Planning Commission discussion. Vice Chair Ferguson stated the importance of understanding Universal Design Policy as it is an emerging and trending topic gaining traction in the state.
