FMC 2.44.070, Amended. Section 1 of Ordinance No. 1713 and FMC 19 2.44.070 are hereby amended to read as follows: 20 2.44.070 Monthly Pay. From and after January 1, 2025, the monthly rate of pay for the following positions is fixed at not to exceed the following sums: 21 \$4,039 per month 22 Municipal Court Judge Municipal Court Judge with contract \$5,772 per month 23 Civil Service Chief Examiner \$ 276 per month 24 Section 2. FMC 2.44.095, Amended. FMC 2.44.095 is hereby amended to read as follows: 25 26 2.44.095 Other Hourly Rates of Pay. From and after January 1, 2025, the hourly rate of pay for the following position is fixed at not to exceed the following sum: 27
