CITY OF FIRCREST **RESOLUTION NO. 1972** A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WASHINGTON, **AUTHORIZING** THE FIRCREST, MANAGER TO SUBMIT A FORMAL APPLICATION TO THE **DEPARTMENT COMMERCE** WASHINGTON **STATE** OF TIMELINE **EXTENSION** FOR REQUESTING \mathbf{A} IMPLEMENTATION OF HOUSE BILL 1110. WHEREAS, the Washington State Legislature enacted House Bill 1110 (HB 1110), requiring cities to implement specific middle housing provisions within established timelines; and WHEREAS, the City Council adopted Resolution No. 1943 on November 26, 2024, establishing the Special Middle Housing Ad Hoc Advisory Committee ("Committee") to support City staff in preparing the necessary documentation and materials for requesting a timeline extension for implementation of HB 1110; and WHEREAS, the required Notice of Intent was submitted to the Washington State Department of Commerce ("Commerce") on February 4, 2025, in accordance with Commerce's procedural requirements; and WHEREAS, the draft Formal Application requesting a timeline extension to the timeline for full implementation of HB 1110 was reviewed at the April 14, 2025, City Council Study Session and has been revised to reflect Council feedback; and WHEREAS, the Committee, as an advisory body, does not have the authority to submit the formal application; and WHEREAS, the updated Formal Application is now ready for submission following final staff review. NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE **CITY OF FIRCREST:** Section 1. The City Manager is hereby authorized and directed to submit a Formal Application to the Washington State Department of Commerce requesting a timeline extension for full implementation of House Bill 1110, following completion of final staff review. **Section 2.** This Resolution shall be effective immediately upon adoption.
