# What Can We Do to Preserve Water Sources?

### 1. Home Water Conservation

There are many steps individuals and communities can take to use water more sustainably and reduce waste. Simple actions such as taking shorter showers, turning off the tap while brushing your teeth or washing dishes, and running only full loads in the washing machine can save thousands of gallons of water per household each year. Fixing leaky faucets or pipes is also essential, as even small drips can waste a significant amount of water over time.

# 2. Landscaping and Gardening Choices

Outside the home, replacing manicured lawns and traditional gardens with native plants and drought-tolerant species like succulents can significantly reduce water usage. Where lawns are necessary, watering efficiently in the



early morning and avoiding irrigation on windy days helps minimize evaporation and water waste.

# Swim Lessons:

Session 1: June 23rd – July 3rd

Resident Registration: June 19th 7:00PM

Non-Resident Registration: June 20th 7:00PM

Registration closes when full or on June 22nd at 6:00PM

Group lessons are for children ages 4 and up and are 32 inches tall at the top of the shoulder. All lessons are offered every half hour.

If your child has not participated in swim lessons before or has minimal experience with swimming, we recommend starting in level 1. If your child can swim but needs work on basic stroke or treading water, please consult with one of our head lifeguards for guidance on what level to sign them up for.

Swim lesson ratios are 5:1 student to instructor ratio. Each session is 5 days a week for two consecutive weeks. Morning classes are offered from 9:30 am to 12:00 pm Monday-Friday. Evening Swim Lessons will be offered from 5:00-6:00 pm Monday-Friday. Swim Lesson Sign-ups will take place the Thursday & Friday before each session begins with the exception of Session 2 due to the 4th of July Holiday.

# Pool Rentals

Private pool rentals are only available on Saturdays and Sundays from 8:30 AM to 10:30 AM between May 31st and August 24th, 2025. Saturdays in July are currently on hold pending scheduling for the FAST Swim Team's meets. The party room is available as an add-on in conjunction with your pool rental.

The Party Room is available for rent throughout the year. The rental fee does not include admission to the pool.

# Public Works: Who is Responsible for Maintaining Sidewalks?

Well-maintained sidewalks contribute to neighborhood safety, accessibility, and appearance. Regular upkeep helps prevent injuries, preserves property value, and supports a more walkable and connected community. Property owners play a key role in keeping sidewalks in good condition for everyone's benefit.

Per Fircrest Municipal Code 14.04.020, property owners are responsible for maintaining the sidewalk that adjoins their property, regardless of who originally installed it.

- If the property is privately owned, the owner or occupant must maintain the sidewalk.
- Property owners or occupants are also responsible for maintaining the landscaped strip between the curb and sidewalk, including street trees, gutters, curbs, and parking strips.
- Property owners or occupants are also required to keep the sidewalk in front of their property free from snow, ice, overgrown vegetation, low hanging tree branches, or any other obstructions.

### Why Sidewalks Matter

Sidewalks enhance neighborhood safety, beauty, and walkability by providing space for walking, social interaction, and active transportation—making neighborhoods more livable and connected.

### **Common Sidewalk Hazards**

Typical issues include uneven surfaces or elevation changes (even 1/4 inch can pose a tripping hazard), crack, holes, surface erosion, or chipping, and damage from tree roots.

### **Reporting Hazards**

To report hazardous sidewalk conditions, visit <u>www.cityoffircrest.net/report-a-problem</u>, click "Report a Concern" and complete the form. Reports involving hazards in the City right-of-way are forwarded to Public Works. An inspection will occur and if corrective action is needed, the adjoining property owner will be notified.

# Fircrest History: Growth, Community, and Civic Spirit 1925 - 1937



On September 8, 1925, residents of Regents Park voted to incorporate as the Town of Fircrest, with 88 votes in favor and just 16 opposed. The town was officially incorporated on September 14, 1925. W.A. Woodkirk was elected as Fircrest's first Mayor with 94 votes, and the first Town Council included Dr. J.A. Caswell, C.H. Renschler, D.R. Rogers, E.H. Fox, and Clarence E. Brown.

From 1927 to 1929, Fircrest made major strides in infrastructure, including improvements to the town's water and light systems. On March 12, 1929, voters approved bonds to purchase the water system, which was officially acquired on May 31. These upgrades supported a growing community, which reached a population of 441 by 1930.

The early 1930s saw a strong sense of community take root. The Fircrest Baseball Team was formed and raised funds for equipment and a backstop through box socials and community dances—showcasing early examples of neighbors rallying together. Around the same time, Fircrest resident and inventor Wood Freeman patented the Wood Freeman Automatic Pilot in 1931, a navigation tool that gained national recognition.

On February 16, 1934, the Fircrest Garden Club was founded at Regents Park School. The club led garden shows and beautification efforts across town and joined both the Tacoma-Pierce County League of Garden Clubs and the State Federation by 1935. Civic engagement continued to flourish in 1936, when the Fircrest PTA and Pre-School launched the "Toys Made in Fircrest" Christmas project during the Great Depression, creating handmade gifts for children through sixth grade.



In May 1937, a local non-profit organization, the Fircrest Recreation Association, was established. The group played an active role in promoting recreational, social, and community activities, particularly those geared toward the town's youth.

These early years reflect the strong foundation of leadership, innovation, and the community pride that continues to shape Fircrest today.
