CITY OF FIRCREST 1 **ORDINANCE NO. 1741** 2 AN ORDINANCE OF THE CITY OF FIRCREST, WASHINGTON, AMENDING FIRCREST MUNICIPAL CODE (FMC) SECTION 1.04.020 3 RELATING TO PUBLIC WORKS FACILITY OPERATING HOURS: 4 AMENDING FMC 1.04.030 RELATING TO COMMUNITY CENTER OPERATING HOURS; ADOPTING A NEW FMC SECTION 1.04.050 5 RELATING TO HOLIDAY CLOSURES AND TEMPORARY ADJUSTMENTS TO OPERATING HOURS OF CITY OFFICES AND 6 **PROVIDING FOR SEVERABILITY**; **AND FACILITIES:** 7 ESTABLISHING AN EFFECTIVE DATE 8 WHEREAS, RCW 35A.21.070 provides that all code cities shall prescribe the days and 9 hours of operation of City offices for the transaction of business; and 10 WHEREAS, by Ordinance No. 1238, codified at Fircrest Municipal Code ("FMC") 11 Section 1.04.010, the City of Fircrest ("City") established office hours for the transaction of business at City Hall; and 12 WHEREAS, Ordinance No. 1238, codified at FMC 1.04.020, established office hours 13 for the transaction of business for the City's public works facility; and 14 WHEREAS, Ordinance No. 1435, codified at FMC 1.04.030, modified office hours for 15 the transaction of business at the City's Community Center; and 16 WHEREAS, Resolution No. 1980 authorized the City Manager to execute a collective bargaining agreement with Teamsters Local Union No. 117 ("CBA"), which adjusts 17 public works facility hours; and 18 WHEREAS, the City Council finds that the existing public works office hours should 19 be modified to align with the hours of operation specified in the CBA; and 20 WHEREAS, the City Council also finds that the existing Community Center hours 21 should be modified to align with current City activities; and 22 WHEREAS, the City Council desires to adopt a new section within Chapter 1.04 of the FMC to allow for flexibility in the hours of operation for City offices and facilities, as 23 deemed necessary and appropriate by the City Manager to ensure the efficient operation of the City and its facilities and to establish provisions for holiday closures; 24 25 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF FIRCREST DO 26 **ORDAIN AS FOLLOWS:** 27 Section 1. FMC 1.04.010 (City Hall Hours for Transaction of Business), Amended. 28 Fircrest Municipal Code Section 1.04.010 (City Hall hours for transaction of business)

is hereby amended to read as follows:

1	Normal office hours for City Hall for the transaction of business shall be from 8:00 a.m. to 5:00 p.m., Monday through Friday.

4	Section 2. FMC 1.04.020 (Public Works Facility Hours for Transaction of Business), Amended. Fircrest Municipal Code Section 1.04.020 (Public works facility hours for
5	transaction of business) is hereby amended to read as follows:
6	1.04.020 Public Works Facility hours for transaction of business.
7	Normal office hours for the Public Works Facility for the transaction of business shall be from 8:00 a.m. to 4:30 p.m., Monday through
8	Friday. As authorized by the City Manager, normal Public Works office hours shall be from 7:00 a.m. to 3:30 p.m., Monday through
9	Friday, during the period beginning on the Monday following the start of Daylight Saving Time and ending on the last Friday before the return
10	to Standard Time.
11	Section 3. FMC 1.04.030 (Community Center Hours for Transaction of Business),
12	Amended. Firerest Municipal Code Section 1.04.020 (Public works facility hours for transaction of business) is hereby amended to read as follows:
13	
14	1.04.030 Community Center hours for transaction of business. Normal office hours for the Community Center for the transaction of
15	business shall be from 8:00 a.m. to 9:00 p.m., Monday through Friday,
16	and from 9:00 a.m. to 5:00 p.m., each Saturday and Sunday.
17	Section 4. New FMC Section 1.04.050 (Temporary Adjustments to Hours of Operation for City Offices and Facilities), Adopted. A new Firerest Municipal Code
18 19	Section 1.04.050, to be entitled "Temporary adjustments to hours of operation for City officers and facilities," is hereby adopted to read as follows:
	1.04.050 Temporary adjustments to hours of operation for City
20	offices and facilities.
21	The City Manager is authorized to temporarily adjust the hours of operation for City offices and facilities on a short-term basis, as
22	necessary, to ensure the efficient and effective delivery of City services
23	or to address specific needs or special circumstances, with concurrence of the Mayor.
24	Section 5. Corrections. The City Clerk and codifiers of the ordinance are authorized to
25	make necessary corrections to this ordinance, including, but not limited to, the correction
26	of scrivener/clerical errors, references, ordinance numbering, section/subsection number and any references thereto.
27	Section 6. Severability. If any section, subsection, paragraph, sentence, clause, or phrase
28	of this ordinance is declared unconstitutional or invalid for any reason, such invalid shall not affect the validity or effectiveness of the remaining portions of this ordinance.
