Public Works: Property Owner Vegetation Maintenance

Property owners are responsible for maintaining private trees and all other vegetation in the right-of-way adjacent to their property. This includes ensuring that sidewalks, planting strips, alleys, and streets remain free from obstructions caused by overgrown branches or shrubs.

According to Fircrest Municipal Code 22.62.005, it is a violation to allow vegetation or private trees to obstruct the public right-of-way. Overgrown vegetation not only creates safety hazards but also presents accessibility barriers for people with disabilities, rendering pathways non-compliant with the Americans with Disabilities Act (ADA).



To ensure safety and accessibility for all users, the following minimum clearance standards must be maintained:

- Sidewalk Clearance: Vegetation must be trimmed to allow a minimum 8 feet of vertical clearance over the full width of the sidewalk to ensure safe and accessible passage for all pedestrians, including those using mobility devices or pushing strollers.
- Street/Alley Clearance: A minimum 14 feet of vertical clearance must be maintained over streets and alleys to allow safe passage for emergency vehicles, delivery trucks, and other traffic.

Additional guidelines:

- Keep shrubs and branches from encroaching onto sidewalks or into the street.
- Maintain clear visibility at corners and intersections.
- Do not leave trimmings or debris in the public right-of-way.

If you have questions or need help identifying vegetation that requires trimming, please contact the Public Works Department.

Tree Removal Information

The City of Fircrest regulates the removal of trees on both public and private property. Please review the following guidelines before proceeding with any tree removal activity.

Tree Removal Authority: Tree removal from public areas such as street rights-of-way, planting strips, parks, and arterial streets requires prior City approval and is subject to specific regulations. On private property, the City only regulates the removal of nonconforming trees in public-adjacent strips, and hazardous or diseased trees that pose a threat to public safety. An arborist report may be required to assess the tree's condition.

Public Safety Hazard Trees: The City may require the removal of trees—even on private property—if they overhang or interfere with public streets or sidewalks or are deemed by a City official to pose a danger to life, health, safety, or property. Property owners must comply within 14 days of receiving notification from the City.

Tree Retention Requirements: Tree retention standards **do not** apply to existing single-family lots unless one of the following applies: New home or building construction, development of vacant or underutilized land, or major additions or remodels. If any of these conditions are triggered, tree retention regulations will apply.

37th Annual Fircrest Picnic & Rod Run Draws a Crowd and Classic Cars



Fircrest's Growth and Community Spirit: 1940-1955



During the 1940s, Fircrest continued to grow as a close-knit, civic-minded community. In April 1941, Fircrest Park was officially granted to the Metropolitan Park District, beginning a lasting partnership that supported local recreation for nearly two decades. As World War II unfolded, the town stepped up with its own Civil Defense program and Volunteer Fire Department. In January 1942, Mayor Lakin formed the Fircrest Home Defense Council to coordinate local efforts, and by 1943, the Volunteer Fire Department was fully established under the leadership of longtime resident Wood Freeman, Fircrest's first Fire Chief.

Freeman was more than a community leader—he was an inventive mind with national impact. Born in the early 1900s and raised in Fircrest, he developed his skills aboard his family's deep-sea trolling boat out of Tacoma. In 1937, he patented the Metal Marine Pilot, a magnetic-compass-based self-steering device for boats. Manufactured locally under Metal Marine Pilot, Inc., Freeman's invention became one of the first successful marine autopilots, known for its durable and simple design. Despite its widespread use, Freeman remained deeply connected to Fircrest throughout his life.

In 1945, Fircrest's Town Hall moved from the Methodist Church into the newly renovated Public Utility Building. The original church building, located at 909 Dartmouth Street, still stands today as Liberty Baptist Church, its early role as Fircrest's first seat of government an important chapter in the town's history.

By the late 1940s, Fircrest was drawing regional attention. From 1947 to 1949, the Fircrest Golf Course hosted the popular Fircrest Open, bringing visitors to the growing community. In 1949, the town celebrated the dedication of Wainwright School with a tree-planting ceremony led by Mayor Morrison, underscoring Fircrest's commitment to education. That same year, a cement wading pool was added to Fircrest Park through the Metropolitan Park District partnership, providing a summertime gathering spot for families.

As the 1950s began, Fircrest invested in infrastructure to support its expanding population. By 1951, new wells were drilled and a water tank installed to meet rising demand. In 1952, the town expanded for the first time with an annexation southwest of Ramsdell Street. That same year, Oren Satterlee was appointed Fircrest's first full-salaried Chief of Police, marking a new era in professional public safety.

By 1955, local business and civic life were thriving. Manley's Market opened its doors, serving as a convenient shopping destination for families. Also that year, the Fircrest Kiwanis Club was incorporated, beginning a legacy of community service that continues to this day.

These years laid strong foundations for Fircrest's growth, community spirit, and civic pride—qualities that still define the city today.
