FIRCREST, WASHINGTON, AMENDING FEES FOR PARKS,  
RECREATION, AND PLANNING.**

**WHEREAS**, the City of Fircrest is authorized to impose fees and charges for programs and services provided by the City; and

**WHEREAS**, the City Council recognizes the need to periodically amend fees to recover the cost of services as appropriate; and

**WHEREAS**, the City now desires to amend the existing fees and charges for Parks, Recreation, and Planning.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FIRCREST:**

**Section 1.** The City's Taxes, Rates & Fees Schedule is hereby amended as set forth in Exhibit A – Parks & Recreation and Exhibit B – Planning & Building.


**Section 2. Effective Date.** This Resolution shall take effect January 1, 2026.


