RESOLUTION NO. 2017**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
FIRCREST, WASHINGTON, AUTHORIZING THE CITY  
MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT WITH  
THE CITY OF UNIVERSITY PLACE FOR THE DESIGN AND  
CONSTRUCTION OF THE 44<sup>TH</sup> STREET WEST SIDEWALK AND  
PEDESTRIAN SAFETY PROJECT.**

**WHEREAS**, the City of Fircrest and the City of University Place jointly applied for and were awarded a \$2,578,050 federal grant for the design and construction of transportation improvements to 44<sup>th</sup> Street West between 67<sup>th</sup> Avenue West and Alameda Avenue West; and

**WHEREAS**, the federal grant requires each participating city to contribute local funding toward both project design and the required local match, including an estimated \$100,000 per city for design and \$227,475 per city for the construction match; and

**WHEREAS**, an Interlocal Agreement is necessary to establish the respective roles and responsibilities of each city, including grant administration, billing and reimbursement procedures, payment of local match contributions, awarding and administration of consultant and construction contracts, and overall project coordination; and

**WHEREAS**, the Fircrest City Council finds that entering into an Interlocal Agreement is in the best interest of the City and supports safe, efficient, and coordinated delivery of transportation and pedestrian improvements along 44<sup>th</sup> Street West;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FIRCREST:**

**Section 1.** The City Manager is hereby authorized and directed to execute an Interlocal Agreement with the City of University Place for the design and construction of the 44<sup>th</sup> Street West Sidewalk and Pedestrian Safety Project, substantially in the form presented to the City Council.
